#### **TERRI SCHULTS**

Assistant District Attorney, Terri Schultz, attended the meeting to introduce herself and present her experience and qualification to become a Butler County Common Pleas judge.

# **SOLICITOR REPORT**

The Solicitor presented the following report.

The Hogue property clean-up case is closed. It is a clean-up success.

The Connell property is scheduled to go to court.

The Sportsman's Supply Company court case is in the process.

A visit to the Geibel property is scheduled for April 21, 2023.

### **RAILS-TO-TRAILS AGREEMENT**

The Rails-To-Trail Agreement will be signed and submitted to the Summit Authority and Buffalo Township for signatures.

#### **BASA SALE**

Willie Adams motioned for Summit Township to file objections to the sale of Butler Area Sewage Authority (BASA) to PA American Water. Rick Green seconded the motion. Motion Carried Unanimously.

Willie Adams motioned for the approval of the Memorandum of Understanding between Summit Township and Center Township objecting to the Butler Area Sewage Authority (BASA) sale. Rick Green seconded the motion. Motion Carried Unanimously.

Willie Adams motioned to sign a Non-Disclosure Agreement between Summit Township, Center Township and Gallagher Law Group to have Tim O'Brien provide public relations for the litigation involving the sale of BASA. Mr. O'Brien hourly rate will be \$150.00. Center Township will pay 80% of expenses incurred and Summit Township will pay 20% of the expenses. This is based upon the number of EDUs in each respective Township. Rick Green seconded the motion. Motion Carried Unanimously.

Willie Adams motioned to ratify the payment of O'Brien Communications invoice INV0010-0423/S for public relation services for \$100.00. Rick Green seconded the motion. Motion Carried Unanimously.

#### **SPEED LIMIT ORDINANCE**

Willie Adams motioned to approve Ordinance #85 that has a speed limit of 25 mph on Shepperd Drive. The fine amount will be consistent with the applicable fine set forth in the Pennsylvania Motor Vehicle Code at the time of the violation. Rick Green seconded the motion. Motion Carried Unanimously.

#### WANDERING DOG ORDINANCE

Pennsylvania has a law that dogs are not allowed to run at large. Summit Township has a dog ordinance that prohibits dogs from wandering. Dogs are required to stay on their own property. Summit Township will enforce dogs running at large.

#### POLICE ENFORCEMENT OF ORDINANCES

Saxonburg police can enforce Summit Township's ordinances.

#### **WELTER SUBDIVISION**

The Tim Welter subdivision at Binsey Road was reviewed by the Supervisors, Township's engineer, planning commission and Butler County Planning Commission.

The Township's planning commission found the plan to be administratively correct and recommended approval.

Willie Adams motion to approve the Tim Welter subdivision at Binsey Road contingent upon Butler County's Planning Commission approval. Larry Osche seconded the motion. Motion Carried Unanimously.

## BRESNEHAN CARRIAGE HOUSE/FARM WORKER'S SECONDARY RESIDENCE

Jason Bresnehan attended the meeting regarding the requirements for a carriage house/farmer worker's secondary residence at a farm that is in a Residential (R-1) Zoning District. A zoning hearing is required for this use.

## SCHOOL DISTRICT PROPERTY LOCATION

The Solicitor determined that the entire house at 376 Saxonburg Road is in Summit Township. Therefore, the entire parcel is properly taxed to Summit Township and a proper member of Butler Area School District.

## **BCATO SPRING CONVENTION**

Willie Adams motioned to approve the Supervisors, Secretary/Treasurer, Planning Commission members and Zoning Field Officer to attend the Butler County Association of Township Officials (BCATO) spring convention on May 18, 2023. Rick Green seconded the motion. Motion Carried Unanimously.

#### HERMAN VFC EARNED INCOME TAX CREDIT

Kody Marsico and Ronald Marsico, Jr. applied for the Herman Volunteer Fire Company earned income tax credit. The Township secretary confirmed that Kody Marsico and Ronald Marsico, Jr. are on the eligibility list.

Willie Adams motioned to approve Kody Marsico and Ronald Marsico, Jr. for the Herman Volunteer Fire Company earned income tax credit. Rick Green seconded the motion. Motion Carried Unanimously.

#### **ENGINEER REPORT**

The engineer reviewed the Tim Welter subdivision plan at Binsey Road.

# SIMON DRIVE, HEADLAND ROAD AND BONNIEBROOK ROAD

Larry Osche motioned to approve PennDOT's request for traffic to be detoured onto Simon Drive, Headland Road and Bonniebrook Road while work is being performed on Herman Road. Schnur Road will be closed while work is carried out on Herman Road. Rick Green seconded the motion. Motion Carried Unanimously.

# **LIMESTONE**

Larry Osche motioned to sell the 1B stone that is left from the vacuuming of roads that were seal coated. The Township has no use for this size of stone. Willie Adams seconded the motion. Motion Carried Unanimously.

#### **ROADMASTER REPORT**

The Roadmaster presented the following report:

- 1. Storm damage clean-up was performed.
- 2. Traffic control was provided for the Bonnie Drive project.
- 3. Stutz Road project has begun.

The backhoe cylinder is leaking, and needs repaired.

## **ADDITIONAL BUSINESS**

Willie Adams announced an informational meeting was held on April 17, 2023 at 8:30 a.m. with PennVest regarding funding for the public sewage project. Larry Osche and Willie Adams attended.

Willie Adams motioned for the Township's secretary/treasurer attend a grant funding session that is sponsored by the Buffalo Creek Coalition. Rick Green seconded the motion. Motion Carried Unanimously

## **OPEN TO THE FLOOR – PUBLIC PARTICIPATION**

Adam Tilko inquired if Harvest Lane could become a Township road. The lane would have to be brought to the Township's specification for a road, however, the Township is not obligated to take over the maintenance of the road.

Larry Osche motioned to adjourn the meeting. Rick Green seconded the motion. Motion Carried Unanimously. The meeting adjourned at 8:10 p.m.
