SOLICITOR REPORT

The Sportsman Supply court case for the storage containers is in progress.

A default judgment will be filed in the Connell clean-up case.

The Rails-To-Trails Agreement for the public sewage project has been submitted to Buffalo Township for approval.

A meeting with Summit Academy attorney for a letter of support for the public sewage project will be scheduled.

COMMUNTIY DEVELOPMENT BLOCK GRANT (CDBG) POSTCARD MAILING

Willie Adams motioned for all properties in the public service area to be sent a postcard informing them that the Community Development Block Grant (CDBG) funding application is now available. The deadline to apply is July 31, 2023. The grant will pay the \$6,000.00 mandatory tap-in fee for the public sewage for low to moderate income residents. Rick Green seconded the motion. Motion Carried Unanimously.

RECYCLE CONTAINER

An outside recycle container for paper at the Township property will be researched.

ENGINEER REPORT

The engineer completed reviews for the Welter subdivision, Gagliardi property stormwater information, PA American Water Act 537 Plan for the purchase of Butler Area Sewage Authority (BASA).

STEPHENSON EQUIPMENT OPEN HOUSE

Larry Osche motioned for the road department employees and Township secretary to attend the Stephenson Equipment open house on May 25, 2023. Willie Adams seconded the motion. Motion Carried Unanimously.

GUIDERAIL GRASS

Larry Osche motioned for Penn Township to use their certified personnel to spray grass and weeds along the Township's guiderails for a donation not to exceed \$500.00. Willie Adams seconded the motion. Motion Carried Unanimously.

STONE BID

Larry Osche motioned for the advertisement of the stone bid. Rick Green seconded the motion. Motion Carried Unanimously.

SUPER P HOPPER SPREADER

Larry Osche motioned to ratify the purchase of a Super P Hopper spreader for \$6,900.00. Rick Green seconded the motion. Motion Carried Unanimously.
