SOLICITOR REPORT

Ryan Veinotte and Max Merhaut attended the meeting to discuss the requirements for an agribusiness with learning center and small house in a residential zoning district.

An agribusiness with a training center is permitted in a residential zoning district. A minimum of five acres is required with no more than ten acres. The training center building must adhere to all commercial building requirements.

A small house such as an office trailer with a bathroom, kitchen, and bedroom is permitted. The office trailer must meet all building codes. Be installed by a certified installer. Pass all required building inspections. An on-lot sewage system and water well are required.

If there is a shared driveway for access to the property, a maintenance agreement must be recorded at the Butler County Courthouse.

EAGLE SCOUT HOMETOWN HERO BANNERS PROJECT

Rick Green motioned to authorize Willie Adams, Chairman of the Board of Supervisors, to sign Garrett Kamerer's Eagle Scout workbook for the Hometown Hero Banner Project. Willie Adams seconded the motion. Motion Carried Unanimously.

MOORE SUBDIVISION

The Estate of John A. Moore subdivision at 130 Tower View Drive, Butler, PA was reviewed by the Township Planning Commission and Township engineer. The Planning Commission found the minor subdivision plan to be administratively correct and submitted a recommendation letter of approval.

Willie Adams motioned to approve the Estate of John A. Moore subdivision as administratively correct contingent upon a positive review from Butler County Planning Commission. Rick Green seconded the motion. Motion Carried Unanimously.

HUNTER BODY SHOP

The Hunter Body Shop Expansion development plan at 174 Oneida Valley Road, Butler, PA was reviewed by the Township Planning Commission and Township engineer. The Planning Commission found the development plan to be administratively correct and submitted a recommendation letter of approval.

Willie Adams motioned to approve the Hunter Body Shop Expansion development plan as administratively correct contingent upon a positive review from Butler County Planning Commission. Rick Green seconded the motion. Motion Carried Unanimously.

McGRADY-BARNES LOT LINE REVISION

Rick Green motioned to amend the Agenda to include the McGrady-Barnes Lot Line Revision. Larry Osche seconded the motion. Motion Carried Unanimously.

The McGrady-Barnes lot line revision at 375 Mitchell Hill Road, Butler, PA was reviewed by the Township Planning Commission, Township engineer, and received a positive review from Butler County Planning Commission. The Township Planning Commission found the plan to be administratively correct contingent upon the applicant signing the application or submitting a letter authorizing the surveyor to sign the application. A recommendation letter of approval was submitted.

Rick Green motioned to approve the McGrady-Barnes lot line revision as administratively correct contingent upon the applicant signing the application or submitting a letter authorizing the surveyor to sign the application. Larry Osche seconded the motion. Motion Carried Unanimously.

CDBG COOPERATION AGREEMENT UPDATE

Willie Adams motioned for the cooperation agreement with the Redevelopment Authority for the housing rehabilitation program increase the limit to \$24,000.00 per household due to the rise in costs of materials and labor. Rick Green seconded the motion. Motion Carried Unanimously.

INSURANCE AGENT

Willie Adams motioned to approve Jerich Insurance Agency, Inc. as the Township's insurance agent. Rick Green seconded the motion. Motion Carried Unanimously.

HERMAN VFC FIRE TRUCK

David Barry submitted to the Board of Supervisors a letter from the Herman Volunteer Fire Company requesting an annual donation of \$25,000.00 per year for ten years for the duration of a loan for a fire engine.

The Board of Supervisors will hold an executive session to discuss the donation request.

ENGINEER REPORT

The engineer reviewed the Estate of John A. Moore subdivision plan, Hunter Body Shop Expansion development plan, McGrady-Barnes lot line revision plan. The Weiland subdivision plan is under review.

STONE BID RESULTS

Larry Osche motioned to award to the only bidder M & M Lime Company, Inc., the stone bid for a total of \$121,741.00. Rick Green seconded the motion. Motion Carried Unanimously.

SAFE DIGGING TRAINING

Larry Osche motioned to send five road department employees to a safe digging training on June 23 2022 at Zelienople, PA. Willie Adams seconded the motion. Motion Carried Unanimously.

ROADMASTER REPORT

The Roadmaster presented the following report.
