#### **CALL TO ORDER**

Willie Adams called the meeting to order at 6:45 p.m.

The Linda Slick Minor Subdivision Plan, engineer's review letter, and Planning Commission's recommendation letter for approval were reviewed.

Rick Green motioned to approve the Linda Slick Minor Subdivision Plan contingent upon receiving approval from the Butler County Planning Commission. Larry Osche seconded the motion. Rick Green voted "yes". Larry Osche voted "yes". Willie Adams voted "no". Motion Carried.

## **SOLICITOR'S REPORT**

The Solicitor contacted Butler Township regarding Source Well Cooperative Purchasing but has not received a response.

The Auditor recommends that the Summit Authority file a 2019 DCED Financial Audit Report. The Solicitor will research the Authority's incorporation status to ensure that it is active.

The Authority's Engineer, Rick Barnett, will be submitting the Self-Liquidating Debt Report to the Solicitor for the Borrowing Base Certificate for Summit Authority's interim financing of the public sewage project.

## **CYBER SECURITY POLICY**

The Cyber Security Policy was discussed. It was determined that the policy will be implemented.

Willie Adams motioned to adopt the Cyber Security Policy. Rick Green seconded the motion. Motion Carried Unanimously.

# **TRAFFICE LIGHT MEETING**

A meeting is scheduled on Friday, June 21, 2019 with Jeremy Dias from Senator Joe Pittman office, Representative Marci Mustello, Butler County Maintenance Department, and PennDOT regarding the upgrading of the overhead and wall mounted lights at the intersection of Route 422, Route 68 and Route 38 to LED lighting. Jeremy Dias recommended for the Township's Solicitor to attend the meeting.

Larry Osche motioned for the Township's Solicitor, Michael Gallagher, attend the traffic lighting meeting on Friday, June 21, 2019 at the Township building. Rick Green seconded the motion. Motion Carried Unanimously.

#### **ENGINEER'S REPORT**

The Engineer did not have anything to report.

## **ROADMASTER REPORT**

Roadmaster, Larry Osche, presented the following report:

- 1. Water run-off cleanup and tree removal from storms.
- 2. Road maintenance.
- 3. Equipment maintenance.
- 4. Potholes patching.

Binsey Road Phase II project has been inspected and the documentation has been submitted to Butler County Conservation District for reimbursement from the Dirt, Gravel and Low Volume Grant.

Larry Osche is scheduled to meet on Friday, June 21, 2019 with Butler County Conservation District for the stream requirements for piping on the Binsey Road Phase II Project.

The John Deere tractor boom was replaced due to cracking.

Trooper Michel of the State Police was contacted regarding trucks traveling on Linnwood Drive that are over the road's weight limit. The area will be patrolled.

The road department is working on the pull-off area on Bonniebrook Road for Trooper Michel to weight check trucks.

An application for the Dirt, Gravel and Low Volume Road Grant for Stutz Road will be submitted.

Old East Butler Road project is on the schedule.

The bid opening for the Bonniebrook Road Multimodal Transportation Fund Grant is scheduled for July 8, 2019 at 10:00 a.m. The bid award is scheduled for July 9, 2019 at 10:00 a.m.

## **ADDITIONAL BUSINESS**

The 2019 allocation of the Community Development Block Grant (CDBG) was received.

Willie Adams motioned for the 2019 CDBG funds be allocated for the mandatory sewage tap-in fees for eligible low-income residents in the sewage service area.
