The Treasurer presented the following report:

Deposits included the 2019 Act 13 Funding, Earned Income Taxes and Local Services Taxes.

Disbursements included the first installment payment for the Multimodal Transportation Fund Grant for the drainage phase of the Bonniebrook Road project. Act 537 Plan design phase of the public sewage project. Road materials and guide rails.

SUIT-KOTE BINSEY ROAD PROJECT

Todd McConnell and Sam Slipllow from Suit-Kote attended the meeting to discuss the payment of invoice 665017 for the application of oil on Binsey Road for \$8,552.70. Sam Slipllow acknowledged that Suit-Kote's truck had an electronic calibration error which resulted in an inefficient amount of oil being applied to the road.

The Township recognized immediately that the correct amount of oil was not being applied and it did not flow completely through the stone. This was brought to the truck driver's attention. However, the truck driver disputed that the correct amount of oil is being applied according to his instruments. A second pass of oil was applied to try to have the oil adhere properly to the stone.

Sam Slipllow from Suit-Kote does not want to assume any responsibility for the obvious error with oil application. Further discussion is required for the payment request.

The Summit Authority will reimburse the Township for this invoice upon receiving funding. Larry Osche seconded the motion. Motion Carried Unanimously.

SOLICIITOR'S REPORT

An Agreement for the Township's withdrawal of civil and criminal complaints at the District Magistrate against Tony Gagliardi, Delores Gagliardi, Louis Gagliardi was reviewed by the Gagliardis and their attorney. The Gagliardis decided not to agree to the terms in the Agreement.

As per the Township Solicitor's recommendation, Willie Adams motioned to withdraw the District Magistrate civil and criminal complaints and file instead with the Court of Common Pleas for the zoning and stormwater managements violations against Tony Gagliardi, Delores Gagliardi and Louis Gagliardi. Rick Green seconded the motion. Motion Carried Unanimously.

RESOLUTION 2020-10 ACT 13 IMPACT FEES

Willie Adams motioned to approve Resolution 2020-10 for the allocation of 2019 Act 13 Impact Fees of \$163,893.40 to the Capital Fund to be expended for Act 13 Impact Fees permitted uses. Rick Green seconded the motion. Motioned Carried Unanimously.

ETZEL PERMANENT HOLDING TANK

Willie Adams motioned to approve the Permanent Holding Tank Maintenance Agreement with Justin J. Etzel at 117 Herman Road, Butler, PA to be recorded at the Butler County Recorder's of Deed office. Rick Green seconded the motion. Motion Carried Unanimously.

VETERAN MEMORIAL

Rege Karch would like to construct a veteran memorial at 108 Dittmer Road, Butler, PA. The plans for the memorial will be submitted to the Township's Planning Commission for review and approval from the Township Board of Supervisors before the project will begin. The Township's Solicitor, Michael Gallagher, will donate his time to draft a Maintenance Agreement with the Township for the veteran memorial.

ROUTE 68 TREE TRIMMING FOR FIRE ALERT SIGN

Trees on Route 68 are obstructing the fire alert sign for the Lick Hill Volunteer Fire Company.

Rick Green motioned for the trees to be trimmed on Route 68 as to not obstruct the visibility of the fire alert sign for the Lick Hill Fire Company. Willie Adams seconded the motion. Motion Carried Unanimously.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following report:

- 1. Road berming performed.
- 2. Cutting of grass.
- 3. Equipment maintenance performed.

Larry Osche motioned for 2" of FB-2 binder be sealed on Bish Road this year. Rick Green seconded the motion. Motion Carried Unanimously.

The air conditioner on a 2003 Peterbilt truck is being replaced.

Larry Osche motioned for the paving of Osche Road due to the road's condition. This will increase our paving project approximately \$40,000.00. Rick Green seconded the motion. Motion Carried Unanimously.

ADDITIONAL BUSINESS

There was no additional business.

OPEN TO THE FLOOR – PUBLIC PARTICIPATION.

Residents attended the meeting regarding ATV vehicles traffic and target shooting with semi-automatic weapons on Kaiser Road. The State police has jurisdiction for these issues.

The Board of Supervisors with the Township's Solicitor held an executive session. No decisions were made.
