# CONSTRUCTION AGREEMENT FOR BINSEY ROAD COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROJECT

Larry Osche motioned to approve and authorize Chairman, Willie Adams, to sign the Construction Agreement for the Community Development Block Grant (CDBG) Binsey Road project. Rick Green seconded the motion. Motion carried unanimously.

# HERMAN VOLUNTEER FIRE COMPANY SUV LOAN

Willie Adams motioned to ratify from the previous meeting the authorization for Willie Adams to sign a letter for Herman VFC stating that the fire company provides emergency services to the Township. The letter is required for the fire company to obtain a loan for an SUV for medical responses. The Township has no financial responsibilities. Rick Green seconded the motion. Motion carried unanimously.

# **LINE PAINTING**

Larry Osche motioned to approve the line painting of Linnwod Drive, Stutz Road, and Bonniebrook Road from Route 422 to the Herman Road intersection for a cost of \$10,220.28. Rick Green seconded the motion. Motion carried unanimously.

#### **LINNWOOD DRIVE**

A water drainage issue at Linnwood Drive was discussed and no action was taken.

# **ROADMASTER REPORT**

Roadmaster, Larry Osche, presented the following report:

- 1. Storm damage clean-up performed.
- 2. Salt bins loaded.
- 3. Equipment maintenance performed.

Binsey Road has a vehicle chasing dog issue. The Roadmaster has spoken to the dog owner's relative multiple times requesting that the dog be contained on its' property so not get hit by a vehicle. The relative agreed to relay this request. The issue has not been resolved. A letter will be sent to the dog owner explaining that the dog is not allowed to roam at large and the safety issue it is causing.

The 2023 Ford F-550 engine is being replaced. It is under warranty.

A driveway permit has been obtained for 290 Bonniebrook Road. An agreement will be drafted with the property owner and the Township for an 18" drainage pipe project. The property owner will be responsible for the legal costs of drawing up the agreement and the Butler County recording fees.

# **ADDITIONAL BUSINESS**

There was no additional business.

# **OPEN TO THE FLOOR – PUBLIC PARTICIPATION**

The SUV for Herman Volunteer Fire Company medical responses is being outfitted.

The Herman Volunteer Fire Company Relief Audit has been completed and the report should be submitted either September or October.

With there being no further business to come before the board, Rick Green motioned to adjourn the meeting. Larry Osche seconded the motion. Motion carried unanimously. The meeting was adjourned at 7:45 p.m.
