Rick Green motioned to send a payment request to the Summit Township Board of Supervisors for the above invoices for \$13,072.65. The Authority will reimburse the Township upon receiving funding. Robert Thompson seconded the motion. Motion Carried Unanimously.

# Work in Progress

- 1. A site meeting was held on 7/15/2020 with Ms. Chris Zeigler of the Allegheny Valley Land Trust to re-visit the use of a portion of the Butler-Freeport Community Trail (BFCT) right-of-way (ROW) for the sewer alignment. Drawings of the proposed alignment were provided for BFCT review and potential offerings of parking/restroom areas were discussed as approved at the July Authority meeting. BFCT is reviewing the plans and issues with Buffalo Township and their engineer. A proposed agreement is expected from BFCT/Township for the Authority to consider. The recommended alternative for sewer alignment in the area from Bonniebrook Road to Herman Road will be developed pending resolution of using the trail ROW.
- 2. If the alignment is changed to be located on the Summit Township Sportsmens Club (STSC) property the following additional work would be needed for the new alignment:
  - a. Wetlands investigation \$3,630 (delineation/fieldwork, mapping, and report)
  - b. Phase 1 Archaeological Survey \$9,020 (background research, fieldwork and report)
- 3. Based on discussion at the June Board meeting the collection system may be extended to provide a point of connection to 4 homes in the Kozik area pending additional discussions with the residents. Mr. Ron Kozik was contacted to discuss constructing the lines on private property, tap fees, etc. He has indicated that the property owners are interested in constructing the lines and taps (in accordance with the Authority's specifications) and then turning the collection system over to the Authority for ownership and maintenance. An agreement will be required prior to construction.
- 4. Work continues on the WQM Part II permit application, General information form, Engineers Report, sewage modules, specifications, drawings, GP-5, Chapter 102 (construction stormwater NPDES) and other permit applications. Completion is pending final alignment selections.
