CDBG RESOLUTION 2020-11 ADMINISTRATOR COOPERATION AGREEMENT

Willie Adams motioned to approve Resolution 2020-11 for the Community Development Block Grant (CDBG) application submission and for Butler County to be the grant's administrator. Rick Green seconded the motion. Motion Carried Unanimously.

CDBG ADMINSTRATOR COOPERATION AGREEMENT

Willie Adams motioned for the acceptance of the Cooperation Agreement with Butler County to administer the CDGB grant. Rick Green seconded the motion. Motion Carried Unanimously.

CDBG APPLICATION CERTIFICATION

Willie Adams motioned for the authorization for him to sign the CDBG application certification. Rick Green seconded the motion. Motion Carried Unanimously.

RESOLUTION 2012-12 CDBG 3-YEAR PLAN

Willie Adams motioned to approve Resolution 2020-12 for the CDBG 3-year plan to designate the fund for low-moderate income residents mandatory tap-in fee for public sewage. Rick Green seconded the motion. Motion Carried Unanimously.

FALL-WINTER NEWSLETTER

Rick Green motioned for the publication of a Fall 2020 -Winter 2021 newsletter. The newsletter will be reviewed by the Supervisors before being mailed. Larry Osche seconded the motion. Motion Carried Unanimously.

STUTZ ROAD

Butler County Conservation District and DEP met with Larry Osche regarding funding for Stutz Road from the Dirt, Gravel, and Low Volume grant. The grant requires approval from all Supervisors.

Larry Osche made a motion to apply for the Dirt, Grave and Low Volume Grant for Stutz Road. Rick Green seconded the motion. Motion Carried Unanimously.

BINSEY ROAD

The condition of Binsey Road was discussed.

HEADLAND ROAD

Headland Road is having an issue with stone on the road due to vehicles turning into the berm when turning from Freeport Road onto Headland Road. White road markers will be installed to deter motorists from using the berm to turn onto Headland Road.

McGRADY HOLLOW ROAD

A letter will be sent to the logging company that damaged McGrady Hollow Road. If the road is not fixed to the Township's specification within thirty (30) days, the Township will use the logging company's bond for the repairs.

TRUCK TIRE QUOTE

Larry Osche motioned to approve Elliott's Tire Service, Inc. quote for the Ford F-550 tires for \$1,816.80. Rick Green seconded the motion. Motion Carried Unanimously.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following report:

Larry Osche contacted several contractors for the garage fumes issue to enclose the furnace area. Marra Brother was the only company to respond. A quote will be obtained for the project.

Willie Adams motioned to renew the electricity option with Direct Energy. Rick Green seconded the motion. Motion Carried Unanimously.
