Kennedy Lane project will begin after Old East Butler Road grant project is completed.

Penn DOT is reviewing the Freeport Road and Hinchberger Road intersection tree trimming project. Once a determination is made, the trees will be trimmed.

A meeting is scheduled for September 9, 2019 with the Great Belt Road property owners for the specifications for water issue project.

Bricker Avenue has a water coming through the road. The source needs to be determined.

The vacuuming of loose stone from the seal coat project has been completed.
