ENGINEER'S REPORT

Michael Elisco from Senate Engineering Company presented the following report:

- 1. The Staugh-Huncheck-Bergbigler lot line revision was reviewed and recommendation letter was submitted to the Township.
- 2. Stormwater
 - A. Gagliardi stormwater comments have been reviewed and a comment letter sent to the Township and the applicant's engineer.
 - B. PTV, Dollar General The Engineer has forwarded questions to the applicant and is waiting for a response.
- 3. DEP provided comments to the Act 537 Plan which the Engineer addressed.

LINE PAINTING

Larry Osche motioned to ratify to accept Williams & Wilman Line Painting, Inc. quote for \$4,934.80 for line painting. Rick Green seconded the motion. Motion Carried Unanimously.

TREE TRIMMING

Larry Osche motioned to ratify to advertise for bid the tree trimming of 50 yards of Keck Road and the entirety of Highland Drive. Rick Green seconded the motion. Motion Carried Unanimously.

HINCHBERGER ROAD

Larry Osche motioned to ratify \$8,358.85 for materials for Hinchberger Road to include 500 feet of pipe, three catch basins and road oil. Rick Green seconded the motion. Motion Carried Unanimously.

KECK ROAD

Larry Osche motioned to ratify for the installation of 500 feet of pipe and two catch basins for Keck Road. Rick Green seconded the motion. Motion Carried Unanimously.

ROAD PROJECTS

Larry Osche presented the following road projects.

- 1. He is coordinating with the railroad company the repairs at the Keck Road railroad crossing.
 - Mike Elisco will have an inspector go Keck Road to advise the Township on the repairs for the remainder of the road.
- 2. Work will begin on Geibel Road due to a determination has not been made on the repairs for Keck Road.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following road department report:

- 1. Equipment has been repaired.
- 2. Trees were removed due to storm damage.
- 3. Working on road projects.

A letter will be sent to the residents on Kemar Drive requesting that the reflectors that have been placed on the Township's right-of-way be removed.

A letter will be sent to residents that if the Township trims a tree that has disease and the tree dies after trimming, the Township will not be responsible for the tree.

ADDITIONAL BUSINESS

The Supervisor met on August 28, 2017 to discuss personnel matters.

OPEN TO THE FLOOR

Dave Barry's property has developed a ruts due to the installation of the public water line. Whenever the contractor is the area, Larry Osche will inform them of the ruts.

A resident inquired about the requirements for the installation of a fence. Fences over six feet tall require inspections. It is the property owner's responsibility to ensure that the fence is on their property.

A resident has a neighbor that has an installed a water retention pond on his property without permission. It was recommended that the property owner contact Butler County Conservation District for this matter.

A resident requested that an embankment on Karnes Road be mowed.

With there being no further business to come before the Board of Supervisors, Rick Green made the motion to adjourn. Larry Osche seconded the motion. Motion Carried Unanimously. Meeting adjourned at 8:32 p.m.
