# **SOLICITOR REPORT**

The Solicitor presented the following report:

- A. FIRE DEPARTMENTBILLING: It was determined that the fire companies need to work with one another regarding invoice submission.
- B. SPORTSMAN'S SUPPLY: Oral arguments on preliminary objections are scheduled for October.

A status conference is scheduled for September 26, 2023 regarding the Trufley property clean-up.

The Geibel property clean-up is scheduled for a hearing in April 2024.

An executive session regarding the Butler Area Sewer Authority (BASA) will be held at the meeting.

## **LICK HILL VFD**

Larry Osche motioned to change Lick Hill Volunteer Fire Department's fire beat territory effective September 26, 2023. The fire beat territory will be re-evaluated at the first regular public meeting on January 2, 2024. The Lick Hill Volunteer Fire Department fire beat territory will be North of the North white line of Route 422.

Herman Volunteer Fire Company fire beat territory will include South of the of the North white line of Route 422 including the Mitchell Hill area. Written notification of the beat territory change will be sent to Lick Hill Volunteer Fire Department, Herman Volunteer Fire Company, and Butler County Emergency Services. Willie Adams seconded the motion. Motion carried unanimously.

# **PROPERTY CLEAN-UP**

A. 103 CARBON CENTER ROAD: The property owner will be sent a second notification to clean-up the property.

Willie Adams motioned to approve the Kelli Jo Lovich subdivision plan at 114 Rimp Road, Butler, PA as administratively correct. Rick Green seconded the motion. Motion carried unanimously.

# **WEICHEY SUBDIVISION**

The Curt Weichey subdivision plan was reviewed by the Township's engineer, and Township's Planning Commission. The Township's Planning Commission submitted a recommendation letter of approval for the Curt Weichey subdivision at 494 Route 422 East, Butler, PA contingent upon Butler County Planning Commission reveiw. The Board of Supervisors reviewed the plan.

Willie Adams motioned to approve the Curt Weichey subdivision plan at 494 Route 422 East, Butler, PA as administratively correct contingent upon Butler County Planning Commission review. Rick Green seconded the motion. Motion carried unanimously.
