RESOLUTION 2016-15 BONNIEBROOK ROAD GRANT

Willie Adams motioned to approve Resolution 2016-15 for the request for the Multimodal Transportation Fund Grant for Bonniebrook Road. Rick Green seconded the motion. Motion Carried Unanimously.

DOT TRAINING

ARCHERY HUNTING

Willie Adams motioned to grant archery hunting on the Beck property for township resident, Jamie Venesky, for the 2016 archery season providing that no motorized vehicles will be on the property and all PA Game Commission regulations are followed. Mr. Venesky is to submit a request letter for archery hunting that includes his name, address, telephone number and hunting license number. A Hold Harmless Agreement must be signed by Mr. Venesky that is specifically for him to archery hunt on the property. No other individuals are to accompany Mr. Venesky on the property. The request letter and signed agreement must be submitted prior to archery hunting permission being granted. Rick Green seconded the motion. Motion Carried Unanimously.

The archery hunting request is on a trial basis.

ROADMASTER REPORT

Due to Roadmaster being absent Roxann Stickney submitted the Road Department's work report:
