CD RENEWALS

Rick Green motioned for the General Fund and Capital Fund CD be renewed for 6 months at NexTier Bank. Willie Adams seconded the motion. Motion Carried Unanimously.

ADVERTISEMENT OF 2020 BUDGET

Willie Adams motioned to advertise the 2020 General Fund budget, Capital Fund budget, Fire Hydrant Fund budget, Sewage Escrow Fund budget, Sewage Permit fund budget and State Fund budget for public viewing. Rick Green seconded the motion. Motion Carried Unanimously.

DRIVEWAY SIGNS

The replacement of driveway signs was discussed.

Rick Green motioned that the Township will re-install existing driveway signs when they are knocked down. The Township will install approved replacement driveway signs, but it is the property owner's responsibility for the cost of the sign. The Township will only cover the cost of a driveway replacement sign, if documentation is submitted that the Township agreed to do so. Larry Osche seconded the motion. Motion Carried Unanimously.

STOP SIGNS

Larry Osche has a meeting scheduled for November 7, 2019 with LTAP representatives to determine if the intersection of Bricker Avenue and Shepperd Drive requires a traffic study and meets the criteria for the installation of two stop signs.

DRIVEWAY PERMIT

A.J. Portman, Geary McDevitt and Deborah Moore attended the meeting regarding a driveway permit for gas well access at 365 Portman Road, Butler, PA. The permit was denied due to lack of site distance.

The Township's Solicitor will be contacted regarding the Township's liability if hidden driveway and no left turns signs are installed for the driveway. The property owners will pay for the signs and the Township will install the signs. A determination will be made at the next meeting.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following report:

- 1. Winter equipment was installed on the vehicles.
- 2. Most of the drainage is completed on the Kennedy Lane project. Work is finished for this year and will resume next year.

Equipment that is used for road improvements can be purchased with Act 13 Funds.

The Multimodal Transportation Fund Grant for Bonniebrook Road will require all bidders to be PennDOT qualified contactors with a certification number.

ADDITIONAL BUSINESS

There was no additional business.

OPEN TO THE FLOOR – PUBLIC PARTICIPATION.

Residents attended the meeting with concerns regarding Summit Academy students leaving the premises without permission. It was determined that the Township's Solicitor will be contacted to schedule a meeting with the Township and Summit Academy to discuss this matter.

Residents attended the meeting to discuss the requirements for the hauling of shale material from a property on Herman Road that is in a residential zoning district. It was determined that the Butler Conservation District will be contacted for the requirements of such activities.

The Emergency Management Coordinator requested that properties with solar panels be clearly identified for first responders to be aware of the electrified risk. The Township's Solicitor will be contacted to see if the Township can require the property to be clearly marked of solar panels in use.

ADJOURN

With there being no further business to come before the Board of Supervisors, Rick Green made the motion to adjourn. Larry Osche seconded the motion. Motion Carried Unanimously. Meeting adjourned at 8:42 p.m.
