#### EMERGENCY SNOW REMOVAL QUOTES

The following companies were contacted for emergency snow removal quotes.

- 2. Phil Hay & Sons Excavating, Inc. did not submit a quote.
- 3. The Perfect Touch Landscapers Plus submitted a written quote.
- 4. Wiest Asphalt Products & Paving did not submit a quote

Willie Adams motioned The Perfect Touch Landscapers Plus which was the only company to submit a quote be approved for emergency snow removal for the Township. Rick Green seconded the motion. Motion Carried Unanimously.

#### **ROADMASTER REPORT**

Roadmaster, Larry Osche, presented the following report:

- 2. Trucks were converted over to have winter road maintenance equipment.

An Intergovernmental Agreement with Jefferson Township for emergency snow removal was discussed.

Larry Osche motioned to hire Johnny Marra for part-time, on-call winter road department employee with no benefits. Rick Green seconded the motion. Motion Carried Unanimously.

Rick Green motioned to extend the COVID-19 state of emergency for another week. Willie Adams seconded the motion. Motion Carried Unanimously.

Willie Adams motioned for the approval to sign the 2020 Annual Tax Collector Report. Rick Green seconded the motion. Motion Carried Unanimously.

## OPEN TO THE FLOOR - PUBLIC PARTICIPATION.

David Barry announce 21 individuals from the Herman Volunteer Fire Company qualify for the Earned Income Tax credit.

David Barry informed the Board of Supervisors that the Butler County Treasurer submitted a letter to the Herman Volunteer Fire Company and area non-profits that have a Game of Chance License that fund raiser tickets can only be paid via cash, check or money order. No internet sales are allowed. This is will greatly impact the fire company financially. Representative Marci Mustello has been contacted regarding this issue.

Lockaton Junk Yard annual license will not be renewed if all items in the Township's Agreement and the Township's Junk Yard Ordinance is met.
