## **2017-11 BONNIEBROOK ROAD GRANT**

Larry Osche motioned to approve Resolution 2017-11 for the submission of a joint application with Jefferson Township for the Multimodal Transportation Fund Grant for the reconstruction of Bonniebrook Road from Route 422 to Route 356. Rick Green seconded the motion. Motion Carried Unanimously.
