CALL TO ORDER

Chairman, Willie Adams, called the meeting to order at 6:45 p.m.

2016-19 RECORDS RETENTION POLICY RESOLUTION

Willie Adams motioned to approve Resolution 2016-19 for records retention requirements. Rick Green seconded the motion. Motion Carried Unanimously.

2016-20 DISPOSITION OF TAX COLLECTOR'S RECORDS RESOLUTION

Willie Adams motioned to approve Resolution 2016-20 for the disposition of Tax Collector's records. Rick Green seconded the motion. Motion Carried Unanimously.

It was determined per the auditor's recommendation that the tax collector submit to the township the complete list of tax collections.

HOLDING TANK ORDINANCE

Holding Tank Ordinance was discussed in the Solicitor's report.

CELL PHONES

Cell phone options were discussed with upgrading to iPhones. It was determined the township will not upgrade at this time and stay with our current plan.

ROAD BONDING REQUIREMENT

The road bonding mileage was discussed to have the amount bonded per mile and not increments of mile. It was determined that increments of mile will be the requirement.

ANTI-SKID

Larry Osche motioned to order 250 tons of anti-skid. Rick Green seconded the motion. Motion Carried Unanimously.

ENGINEER'S REPORT

Michael Elisco representing Senate Engineering presented the following report:

- A. The Wolf and Deal minor subdivision review will be completed before the next Planning Commission meeting.
- B. There was nothing to report for stormwater.
- C. Act 537 Update:
 - 1. EDU count was completed.
 - 2. The Act 537 Plan was submitted to the Supervisors for review.
 - 3. The PHMC indicated that a Phase 1 Archaeological Study needs to be completed. Senate Engineering received a quote of \$34,780.00 for the study. The study can be completed during the design phase.

The following items are need for the Act 537 Plan:

- A. The DEP preliminary effluent limits.
- B. Floodplain maps.
- C. Projection of EDUs over the next 20 years.
- D. The township establishing a sewer authority.

Representative Mike Kelly's office was contacted for a meeting to discuss possible federal funding for the sewage plant and system. The township was informed that there is no need for a meeting at this time because there are no funds are available.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following report:

- 1. Snow removal.
- 2. Fallen trees removed.
- 3. Equipment maintenance.
- 4. Building maintenance and the garage lighting was updated to LED lights.
- 5. The pressure washer motor broke and is being repaired.
- 6. Ordered 250 tons of anti-skid.

7. Stutz Road catch basin was clogged and was cleared. Catch basins are on a weekly maintenance schedule.

ADDITIONAL BUSINESS

PA American Water Company is in process of scheduling a meeting with Summit Academy to discuss public water service. Roxann Stickney will contact the water company to request that the Supervisors attend the meeting and that the meeting be held at the township building.

A few properties in disrepair were brought to the township's attention. At this time, the Township does not have a nuisance ordinance to address blight.

OPEN TO THE FLOOR

The Herman Volunteer Fire Company purchased a 2006 rescue truck from Evans City.

It was determined that Butler County did not update 49 tax cards for the Fire Hydrant Tax. Rick Green motioned that the Tax Collector send a letter to the property owners requesting payment for the back taxes. Larry Osche seconded the motion. Motion Carried Unanimously.

With there being no further business to come before the Board of Supervisors, Rick Green made the motion to adjourn. Larry Osche seconded the motion. Motion Carried Unanimously. Meeting adjourned at 8:10 p.m.
