## **BUILDING INSPECTOR 2025 SERVICES**

Larry Osche motioned to approve Code.sys to provide the Township's 2025 building inspections, building permitting and electrical inspections and authorize Willie Adams to sign the contract. Rick Green seconded the motion. Motion carried unanimously.

## **TOWNSHIP LOT LINE REVISION**

The Supervisors reviewed the Township's lot line revision and Planning Commission's recommendation letter of approval.

Larry Osche motioned to approve the Township's lot line revision at 502 Bonniebrook Road, Butler, PA as administratively correct. Rick Green seconded the motion. Motion carried unanimously.

## **COMPACT TRACK LOADER**

The Township was awarded \$105,300.00 from the Local Share Account (LSA) Grant for the purchase of a compact track loader with broom attachment.

Larry Osche motioned to purchase a small track loader with broom attachment from the LSA grant funding for \$110,125.00. The Township will pay the remaining balance. Rick Green seconded the motion. Motion carried unanimously.
