## **Grant Awards**

A Multi-modal Transportation Fund Grant was awarded to Summit Township and Jefferson Township for the reconstruction and paving of Bonniebrook Road from Route 422 to Route 356. The start date for the project has not been determined.

Summit Township has been awarded the Dirt, Gravel and Low Volume Road Grant for a three phase project of Binsey Road.

Old East Butler Road is under consideration for the Dirt, Gravel and Low Volume Road Grant. The awarding of the grant will be later in the summer.

# Summit Elementary Playground

Summit Township has entered into an Agreement with Butler Area School District for the Summit Elementary School playground to be available for public use whenever school is not in session.

The Township and school district have collaborated to apply for a DCNR grant to rebuild the playground. The fund raising effort by the Summit Elementary PTO is currently underway to raise \$20,000.00 to meet the grant's requirement. ## Permit Season

Spring and Summer is the busiest time of year for permits. The most common permits are car ports, swimming pools, sheds, garages, decks and porches. If a project is started without a permit, the fee is doubled and the project will be stopped until the permit is issued. To save time and expense, contact the Township office at 724-285-1168 for permit requirements.

## **Driveway Improvements**

If you are planning to improve or pave your driveway, please contact the Township for the permit and requirements. Should a paving company approach you to pave your driveway, please remember that it is the property owner's responsibility to obtain the permit. If a permit is not obtained, the fee is doubled and the driveway must meet the Township's specifications.
