GEIBEL ROAD PROJECT

Larry Osche motioned to put out for bid the Geibel Road project. Rick Green seconded the motion. Motion Carried Unanimously.

SEAL COAT PROJECT

Larry Osche presented a double seal coat project. Roads will be reviewed for the project.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following road department report:

- 1. Trees were removed due to the weather.
- 2. Salting of roads.
- 3. Berms were fixed that were washed out due to the weather.
- 4. Hinchberger Road needs a pipe due to a water issue near Route 356.
- 5. Stone, pipes and catch basins were ordered for the road projects.

A logging company was timbering on Bonniebrook Road without a Timbering Permit and Road Bond. The company has been contacted and the permit and road bond will be submitted immediately.

Larry Osche motioned to grant the approval for People's Gas to bore under Carbon Center Road contingent the Township's specifications are met. Rick Green seconded the motion. Motion Carried Unanimously.

Quotes for Equipment Rental and Paving Equipment Rental were sent out.

The addition of a road employee was discussed. No determination was made.

A Sewage Authority meeting will be scheduled for Monday March 19, 2018 at 10:00 a.m. The Township Solicitor will be contacted for the Sewer Authority By-laws for the meeting.
