

SUMMER HOLIDAYS

As summer holidays are fast approaching, here are a couple of quick reminders.

- 1. No burning is permitted on legal holidays. However, recreational fires are allowed.
- 2. The Township follows the State fireworks regulations. This link https://www.pa.gov/agencies/ psp/resources/safety-resources/fireworks-faq.html has "Frequently Asked Questions" regarding PA fireworks. This is an excerpt of restrictions.
 - Cannot be ignited or discharged on public or private property without express permission of the property owner.
 - Cannot be directed at another person.
 - Cannot be discharged from or directed at a building or vehicle.
 - Cannot be discharged within 150 feet of a building or vehicle regardless if the building or vehicle is owned by the user of the consumer fireworks.
 - Cannot be discharged while the person is under the influence of alcohol, a controlled substance or another drug.
 - Municipalities may restrict use of consumer fireworks between 10 p.m. and 10 a.m. except: July 2, 3, 4 and Dec. 31 when they may be used until 1 a.m. If July 4 falls on a Tuesday, Wednesday, or Thursday they may be used until 1 a.m. on the immediately preceding and following Friday and Saturday
