JANET HORTERT/SUMMER LAKE SUBDIVISION

Ed Thaner presented to the Board of Supervisors the Janet Hortert/Summer Lake Subdivision on Saxonburg Road for review. Butler Township was the lead township due to most of the plan is in Butler Township. Butler County Planning Commission and Summit Township's planning commissions reviewed the plan. The Township's planning commission submitted a recommendation letter of approval.

RESOLUTION 2023-10 JEFFERSTON TWP. INTERGOVERNMENTAL AGREEMENT BONNIEBROOK ROAD SEALING

Willie Adams motioned to approve Resolution 2023-10 for an Intergovernmental Agreement with Jefferson Township for the sealing of Bonniebrook Road from the Jefferson Township line to Herman Road. Rick Green seconded the motion. Motion carried unanimously.

Willie Adams motioned for the approval of the Intergovernmental Agreement with Jefferson Township for the above referenced Bonniebrook Road sealing project. Rick Green seconded the motion. Motion carried unanimously.

PA AMERICAN WATER SYSTEM UPGRADE ON PORTMAN ROAD

Wilie Adams motioned that the agreement for the PA American water system upgrade on Portman Road be reviewed by the Township's legal counsel. Rick Green seconded the motion. Motion carried unanimously.

ROADMASTER REPORT

The Roadmaster presented the following Report:

- 1. Curve markers were painted on Carbon Center Road.
- 2. Grass cutting was performed.
- 3. Removal of leaves, and debris from catch basins were performed.
- 4. The Road Department provided traffic control on Carbon Center Road for tree trimming.
