# **PLANNING COMMISSION MEMBER**

Willie Adams motioned to advertise in the Butler Eagle and place on the Township's website that the Planning Commission has an opening for a member. Rick Green seconded the motion. Motion Carried Unanimously.

#### **ROADMASTER REPORT**

Roadmaster, Larry Osche, presented the following road department report:

- 1. Cutting of grass along Township roads.
- 2. Brushing stones off roads due to storms.
- 3. Catch basin maintenance.
- 4. Catch basins and pipes were installed on Eyth Road and Valley View Drive.
- 5. Working on Keck Road project.

An embankment on Bonniebrook Road across from St. Mary's Cemetery has washed away.

Geibel Road will be closed June 7, 2018 and June 8, 2018 for milling, widening and paving.

Keck Road is scheduled for the following:

June 8, 2018 - Six inches of stone applied and leveled.

June 11, 2018 - Milling, shooting of oil and rolling of the road.

June 13, 2018 - Shooting of oil and application of fine material.

Force Corporation received XTO Energy bid for the patching of Hinchberger Road. Larry Osche is going to contact Force Corporation and Joe Wiest for the cost to repair the wash out on Hinchberger Road.

An accident occurred on Bonniebrook Road in which signs and guiderails were damaged. An invoice was submitted for the replacement of signs and guiderails to State Farm for the vehicle that caused the damage. State Farm denied payment because they feel that the insured was not liable for the damages. Willie Adams motioned for State Farm client be brought before the District Magistrate for reimbursement of the signs and guiderails. Rick Green seconded the motion. Motion Carried Unanimously.

# **ADDITIONAL BUSINESS**

A resident approached Willie Adams regarding water is ponding on Bonniebrook Road towards Herman Road.

Door hangers will be placed on the door of residents in the sewage service to inform them of surveying activities for the project. The Township's website will be updated as well.

## **OPEN TO THE FLOOR – PUBLIC PARTICIPATION**

The weight limit sign on Dittmer Road needs repaired.

Whenever Dittmer Road is being bermed, traffic will be directed.

The Keck Road project was discussed.

A resident reported potholes on Highland Drive.

Old East Butler Road qualifies for the Low Volume Grant. An application will be submitted.

The Floodplain Ordinance is scheduled for adoption at the Public Meeting on June 20, 2018.
