Larry Osche motioned to approve payment for the following Compass Minerals invoices totaling \$10,133.78 for road salt.

Compass Minerals invoice 1445578 for 92.14 tons of rock salt totaling \$8,299.05

Compass Minerals invoice 1447921 for 20.37 tons of rock salt totaling \$1,834.73

Rick Green seconded the motion. Motion carried unanimously.

Willie Adams motioned to approve the payment for State Worker's Insurance fund for Herman Volunteer Fire Company worker's insurance for \$1,313.00. Rick Green seconded the motion. Motion carried unanimously.

CAPITAL FUND INVOICES APPROVAL

Larry Osche motioned to approve the payment for Cleveland Brothers invoice Y9925501 for the small compact track loader with brush for \$110,125.00. Rick Green seconded the motion. Motion carried unanimously.

The Township will be reimbursed through the Local Services Account (LSA) Grant funding for \$105,300.00.

Willie Adams motioned to approve the health insurance renewal for eligible Township employees. Rick Green seconded the motion. Motion carried unanimously.

ENGINEER REPORT

The Township's engineer submitted an approval letter for the Gagliardi stormwater management plan. The recording of the Operation and Maintenance is the only remaining item to close the case.

SALT CONTRACT 2025 - 2026

Larry Osche motioned to authorize the submission to CoStars the 2025 -2026 contract agreement for 1,500 tons of road salt. Rick Green seconded the motion. Motion carried unanimously.

WHEEL LOADER & COMPACT TRACK LOADER SERVICE AGREEMENT

Larry Osche made a motion to approve a four-year service agreement for the wheel loader and small compact track loader. Upon receiving acceptable clarification, the agreement will be submitted. Rick Green seconded the motion. Motion carried unanimously.

ROADMASTER REPORT

Roadmaster, Larry Osche, presented the following report:

- 1. Plowing of snow and salting roads.
- 2. Equipment maintenance performed.

ADDITIONAL BUSINESS

Willie Adams announced an executive session will be held after the meeting is open to the floor for public participation. No decisions will be made.
