# PA AMERICAN WATER - PORTMAN ROAD FIRE HYDRANT SERVICE

Willie Adams motioned to approve the PA American Water project agreement for fire hydrant service at Portman Road. Rick Green seconded the motion. Motion carried unanimously.

#### **BERKHEIMER CONTRACT RENEWAL**

The Berkheimer contract for earned income tax and local services tax contract with Butler County Tax Collector Committee (BCTCC) is up for renewal. The committee contacted two other tax services companies for a quote, but did not receive a response. A special meeting will be held to determine if a Request for Proposal should be sought or accept Berkheimer's quote.

The Supervisors reviewed the Berkheimer proposal. Larry Osche motioned to renew the contract with Berkheimer for 10 years. Willie Adams seconded the motion. Motion carried unanimously. The decision will be presented at the BCTCC special meeting on October 15, 2025.

#### **CD RENEWALS**

Willie Adams motioned to renew both CDs with Nexier Bank for the 6 months. Rick Green seconded the motion. Motion carried unanimously

## **PENSION STATE AID**

The Pension State Aid in the amount of \$15,839.41 was received on September 24, 2025.

Larry Osche motioned to amend the pension to include in-service distribution. Rick Green seconded the motion. Motion carried unanimously.
