Scope of this Privacy Policy

Your Rights

- 27. Unless otherwise agrees, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other right or remedy.
- 28. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive use of jurisdiction of the English and Welsh courts.
