

RELEASE, INDEMNIFICATION AND HOLD HARMLESS AGREEMENT (GUEST)

I hereby agree to release and discharge from liability arising from negligence **Abe Lincoln Gun Club (ALGC)** and its officers, members, agents, volunteers, participants, and all other persons or entities acting for them (hereinafter collectively referred to as "Releasees" on behalf of myself and my children, parents, heirs, personal representative and estate, and also agree as follows:

1. I acknowledge that gun club activities involve known and unanticipated risks which could result in physical or emotional injury, death, and property damage. I understand that such risks simply cannot be eliminated despite the use of safety equipment, without jeopardizing the essential qualities of the activity. I expressly accept and assume all of the risks inherent in this activity or that might have been caused by the negligence of Releasees upon entering the property of ALGC. My involvement as a participant, spectator, or escort is purely voluntary and I elect to be present despite the risks.
2. While on ALGC property I agree to follow the rules and policies as posted and conveyed to me by Releasees. In addition, if at any time I believe that event conditions are unsafe or that I am unable to participate due to physical or mental conditions, then I will immediately discontinue participation. I further specifically release the Releasees from any claim whatsoever on account of first aid, or other medical treatment or service rendered me or Releasees during my attendance at any activity or event.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Releasees from any and all claims, demands, or causes of action which are in any way connected with my participation in activities, my use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releasees or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
4. I understand that while on ALGC property I am covered under the ALGC insurance for property damage, bodily injury, and liability that also covers the Releasees. I also, however, represent that I have adequate insurance to cover any injury or damage I may suffer or cause while on ALGC property, or else I agree to bear the costs of such injury or damage myself.
5. I hereby state that I am under no legal injunction that prohibits my owning, possessing, handling or using any of the firearms used in the events at ALGC. I further acknowledge the right of Releasees to immediately terminate my participation in activities upon any unsafe behavior or failure of mine to fully comply with ALGC rules and policies.
6. In the event that I file a lawsuit, I agree to do so solely in the state of Illinois, and I further agree that the substantive law of the state of Illinois shall apply.
7. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in effect.

By signing this document, I agree that if I am hurt or my property is lost or damaged while I am on ALGC property, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence. I have had sufficient time to read this document and, should I choose to do so, consult with legal counsel prior to signing. Also, I understand that the activity and/or being on ALGC property may be denied me or that the cost to engage in the activity may be forfeited or significantly greater if I were to choose not to sign this release.
