

**ABE LINCOLN GUN CLUB
CONDITIONAL USE AND HOLD HARMLESS AGREEMENT
APPLICABLE TO ALL MEMBERS**

This agreement is by and between the Abe Lincoln Gun Club (ALGC) and its members. As a result, the agreement is applicable to all members and is effective as of the date that each member signs. It shall remain in force and effect so long as the member remains a member in good standing and for as long as membership is renewed from year to year.

WHEREAS, ALGC is a not-for-profit corporation organized under State of Illinois and is a private club organized for the group benefit of its members with no benefit inuring to any individual member, and

WHEREAS, ALGC operates facilities located at 6360 Pec Road, Springfield IL, and such facilities are available for member use under rules and conditions set forth by the members and officers of ALGC and adopted as by-laws or as administrative rules as placed in effect from time to time, and

WHEREAS, ALGC authorizes the use of the facilities by members as a condition of the execution of this agreement, and provided property damage, bodily injury, and liability insurance covering its property, its members, and its officers.

AUTHORITY

This agreement is established by ALGC by-laws and is a requirement of membership. All members are required to sign and execute this agreement as a condition of membership in good standing. All members are required to execute this agreement by the date established in the by-laws.

All members of the ALGC shall at all times observe and obey all safety and procedural rules and by-laws while on ALGC property. By executing this agreement and entering ALGC the member agrees to the conditions set forth herein. Further, the member acknowledges the hazardous nature of shooting sports and maintenance work activities at ALGC.

INDEMNIFICATION OBLIGATIONS

By executing this agreement, the member agrees to hold harmless ALGC and thereby absolve ALGC of any liability, blame or cost associated with said member's use of ALGC that may arise due to negligence of said member, OR any other damage or harm to other members, guests or other private property that may arise from any actions of said member that are deemed unsafe or in violation of safety rules, by-laws or administrative rules.

LIMITATION ON LIABILITY

Notwithstanding any other provision of this agreement, in no event shall ALGC nor any other member of ALGC be liable for any real, consequential or punitive damages incurred during or associated with any use of ALGC by any member when the negligent or unsafe or imprudent actions of said member results in damages or harm as described herein.

RETENTION OF AUTHORITY

Regardless of any authorized or implied permission by ALGC, or implied property interest in ALGC resulting from the payment of dues or fees, ALGC may at any time, through action enforcing its by-laws or rules, or through an action initiated and taken by its members, or through action by officers of ALGC authorized by the by-laws or rules, rescind permission for the member or group of members to use ALGC when the continued use by said member(s) placed ALGC at financial or operational risk.
