## Agreement

### SERVICES:

Photographer will provide services at wedding ceremony according to package selected. Photographer will attend wedding rehearsal based upon photographer's availability. Photographer will arrive at venue on the wedding day prior to the commencement of formal photographs, to obtain photographs of wedding day details and preparation as needed. Photographer will attend ceremony and reception, capturing details of the day and will exit the event at their discretion after the completion of the traditional reception activities. Images will be delivered to the Client via digital download no later than 4-6 weeks following the ceremony date.

### CANCELLATION:

By Client: Client may cancel this Agreement at any time prior to the event. Upon cancellation, Client will be entitled to a refund of any monies paid, except for the non-refundable deposit.

By Photographer: Photographer may cancel this Agreement only due to an emergency situation. If Photographer cancels, a suitable, replacement Photographer, subject to Client's approval, must be provided. In the alternative, Photographer shall refund all monies previously paid by Client, including the non-refundable deposit.

### COPYRIGHT:

Photographer shall maintain the copyright of all photographs. Photographer grants Client permission to make copies of the images for personal use by Client and their family and friends. Sale, publication, or any other commercial use is specifically prohibited without the prior written consent of Photographer.

### DISPUTE RESOLUTION AND LEGAL FEES:

In the event of a dispute arising out of this Contract that cannot be resolved by mutual agreement, and legal action ensues, the client will be entitled to its legal fees, including, but not limited to its attorneys' fees.

### LIABILITY:

Photographer will make every effort to provide high-quality photography services. Photographer gives the utmost respect to exposure, transportation, and processing of photographs, using professional equipment and backup equipment.

In the unlikely event that your photographs are lost, stolen, lost due to technology malfunction or destroyed beyond our control, liability is limited to the return of all payments you've made. The limit of liability for partial loss of digital media/originals shall be a prorated amount of the exposures lost based on the total number of images.

## Agreement

### DEPOSIT-PAYMENTS:

A deposit is required to reserve services. The deposit amount is 50% of the total fee, unless otherwise disclosed. This amount is applied to the total cost for services. The remaining balance will be due on or before the service date. Deposit amount is subject to change without notice, but will not change after you have paid the deposit. Credit, debit, checks, and cash are all accepted forms of payment at this time. Make checks payable to "Miranda Kott". There is a \$50 fee for all returned checks.

### EDITING/IMAGES:

Photographer will handpick the session's best images. Each of these images will be retouched and enhanced based on Photographer's artistic vision. Photographer reserves the right to edit and release only those deemed creditable as professional in quality and within Photographer's artistic standards.

Images will kept for 12 months by photographer but may not be available after stated time.

### ENTIRE AGREEMENT:

The Parties acknowledge and agree that this Agreement represents the entire agreement between the Parties. In the event that the Parties desire to change, add, or otherwise modify any terms, they shall do so in writing to be signed by both parties.
