SPV1: biomass PROOF OF CONCEPT SITE

Size: 2,700 Hectares

- > 350 Food and Water
- > 350 Manufacturing / Agri-processing
- > 2,000 Biomass Crop Farming

The POC Site (SPV1) will produce:

- Food
 - Enough for 500 families to have 3 meals per day
- Bio Blocks
 - Enough to build houses for 500 families
- Bio Diesel
 - To run all the farming equipment and production plants
- Bio Char
- Textiles
- Carbon Credits



OFFERINGS OF GREENFIELD BIO SOLUTIONS LIMITED

Regenerative farming of biomass

SPV2 thru' SPV6 will be farms of 20,000 Hectares (circa 50,000 Acres) and will consist of:

- > 1,000 ha for Food
- > 1,000 ha for Renewable Energies
- > 18,000 ha for Carbon Farming
- Each farm will feed 3,000 people per day and house
 20,000 families per year
- Production facilities for Bio Blocks, Bio Diesel, and Textiles will provide jobs, clean water and education for the local community
- SPV1 thru' SPV6 will generate:
 - > \$1 Billion in cumulative revenues over 6 years
 - > Year 6 will deliver \$422M with \$302M EBITDA
 - Revenues are spilt 60% Carbon Credits and 40% Bio Products
- It is estimated that 4-5 Million Tonnes of CO2 will be sequestered after 6-years of operation from each farm
