

# Terms and Conditions

**Effective Date:** December 22, 2025

**Organization:** The LauraBishop Burbridge Foundation (the “Foundation,” “we,” “us,” or “our”)

These Website Terms and Conditions (the “Terms”) govern your access to and use of our website, online forms, and related services (collectively, the “Site”). By accessing or using the Site, you agree to these Terms.

## 1. Who We Serve and Our Purpose

The Foundation provides practical support and food donations to veterans, neighbors, and single parents in **Cobb County (Austell, Mableton, and Powder Springs), Douglas County, and Paulding County, Georgia.**

## 2. Eligibility and Acceptable Use

You commit to using the website in a courteous and legal manner.

You may not:

- Use the Site for any unlawful purpose.
- Interfere with the site's security or operation
- Attempt to access non-public areas of the site.
- Submit false or misleading information through our forms.
- Harass, threaten, or abuse others through any communication connected to the Site.

## 3. Program Applications and Assistance

Submitting an application for any Foundation program is **required** to be considered for assistance, but it **does not guarantee** that assistance will be provided.

Program support is subject to:

- Available donations and resources
- Volunteer capacity
- Eligibility requirements for the specific program

We reserve the right to offer partial support, place applicants on a waitlist, or pause/close applications at any time.

## 4. Donations

### 4.1 General

We appreciate donations of any size. Monetary donations are prioritized, but we also accept in-kind donations (including food and supplies).

### 4.2 No Refund Policy (Unless Required by Law)

Donations are generally **non-refundable**, except where required by law.

### 4.3 Donor Responsibility

You represent that:

- You are authorized to use the payment method you provide.
- Your donation is made voluntarily and without expectation of goods or services in return (except where explicitly stated).

## 5. Communications (Email/Text)

By submitting forms on our Site, you consent to receive communications from us by email and/or text message related to:

- Program applications and scheduling
- Volunteer opportunities
- Donation receipts and updates
- Foundation announcements

Message and data rates may apply. You can opt out of non-essential communications at any time by following the instructions in the message or contacting us.

## 6. Intellectual Property

All content on the Site—including text, graphics, logos, and downloadable materials—is owned by the Foundation or used with permission and is protected by applicable intellectual property laws.

You may view, download, and print content for personal, non-commercial use only. You may not reproduce, distribute, modify, or create derivative works without our prior written permission.

## 7. Third-Party Links and Services

The Site may contain links to third-party websites or services. We do not control and are not responsible for third-party content, policies, or practices. Accessing third-party sites is at your own risk.

## 8. Privacy

Your use of the Site is also subject to our Privacy Policy. If there is a conflict between these Terms and the Privacy Policy, these Terms control regarding Site use, and the Privacy Policy controls regarding personal data handling.

## 9. Disclaimers

The Site is provided on an “as is” and “as available” basis.

To the fullest extent permitted by law, we disclaim all warranties, express or implied, including implied warranties of merchantability, fitness for a particular purpose, and non-infringement.

We do not guarantee that:

- The Site will be uninterrupted, secure, or error-free.
- Information on the Site will not always be complete, accurate, or current.

## 10. Limitation of Liability

To the fullest extent permitted by law, the Foundation will not be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of profits or revenues, arising from or related to your use of (or inability to use) the Site.

Our liability for any claim is limited to the amount you paid through the Site in the twelve months prior to the event, or \$100 if no payment was made.

## 11. Indemnification

You agree to defend, indemnify, and hold harmless the Foundation and its officers, directors, volunteers, and agents from and against any claims, liabilities, damages, losses, and expenses (including reasonable attorneys’ fees) arising out of or related to:

- Your use of the Site
- Your violation of these terms
- Your violation of any rights of another

## 12. Changes to the Site or Terms

We may update the Site and these Terms at any time. Changes are effective when posted on the Site unless otherwise stated. Your continued use of the Site after changes are posted means you accept the updated Terms.

## 13. Termination

We may suspend or terminate access to the Site at any time, with or without notice, if we believe you have violated these Terms or if we discontinue it.

## 14. Governing Law and Venue

These Terms are governed by the laws of the State of Georgia, without regard to conflict of law principles.

Any dispute arising from these Terms will be brought in the state or federal courts located in Georgia, unless otherwise required by law.
