Meeting Highlights

Car Show Committee: Dick and Evelyn reported the following information:

A Committee meeting was held on Monday, July 10th. Goody bag items are trickling in. Goody Bag Stuffing will take place on Thursday, July 27th, 6 pm at Alan & Julie's camp in Altona

A drawing of the show set up was shown to members present. The suggestion was made that a separate bin be prepared for registration numbers to be used for the cash drawings. The Ice Cream Vendor will not be available for the day of the show. Saturday set up time was set for 4 pm. Sunday set up will start at 6:30 am. Portapotties will be delivered on Friday and locked until Sunday AM. Dan has offered to haul the Club Trailer down to the site on Saturday. Dick is planning to bring his camper down to stay Saturday night. Dick still needs to call Darlene at Chauvin Agency to secure an insurance rider for the City. And the Volunteer sheet was passed around again in case anyone still wants to sign up.

Paint 'n Sip Party: Monika reported that plans are in place for Sunday, August 13th, 3 pm at the Vesco Ridge Winery. The painting cost will be \$30.00 per person with participants paying for their own wine. We are encouraged to bring snacks to share with the group. Participants will have a choice of two pictures to paint: the American Flag or a silhouette of a Mustang horse. Monika has sent a copy of those pictures for Jayne to post in the August newsletter. Monika will post an invitation on the Club Facebook page.

Wine Cruise Weekend: Dick has the room contract ready to sign then interested participants can start making reservations. The room cost this year will be \$89.00 per night for two or 4 guests per room. The number to call for reservations is 315-788-0700. Anyone interested, please let Dick and Evelyn know so they can plan accordingly. Those participating will plan to meet at Nana's at the corner of Route 11 and the Forest Rd in Ellenburg.

Club Website: Dennis reported that godaddy has begun updating their software. With 7 months remaining on our contract, godaddy refunded the cost of 6 months and informed Dennis that we must start using the new format in 30 days with a new price. Dennis showed us what he has worked up with the new software but that is not available to the public yet. The format will be different but hopefully easier to use. There currently is not a guestbook option available but Dennis can list an email address to use if someone wants to contact us. If a guestbook option does come available, Dennis will check to see that we will be notified of a comment placed there. Dennis is still having issues uploading photos as all those uploaded go into one, potentially massive file that must be sorted through. For now, he will continue using photo collages. Godaddy says that the new software is optimized for use with mobile devices. Dennis also explained that a calendar of events can be linked directly to certain formats of electronic calendars. Since we are not currently using an electronic calendar, the suggestion was made that we not use this style calendar now. We can continue with the Calendar of Events listed in the monthly newsletter with the suggestion made that Dennis change the title of the newsletter page to "monthly newsletter & calendar of events". A motion was made by Alan, seconded by Dick that we continue on with the new godaddy site at a cost of \$247.83 for three years . All members present voted for the motion.

The question was raised whether we want to put a link on the new website to the Club facebook page. Jayne explained that the facebook page is a closed, members only page since we have had trouble in the past with non-members posting inappropriate items. Anyone clicking on such a link would then be told they must submit a request to be allowed on the site. Kayla DeCoste is currently the page administrator and only allows access to current Club members. Any others would be required to pay dues to join the Club in order to be allowed access. Jayne raised the question of whether this might become a frustrating process for everyone involved. We will ask Kayla for her opinion on this and discuss this option further in the future.

New Magnets: Jayne reported that, after consulting with Dennis and Linda, she looked into placing an order with Vistaprint for new Club magnets and Honor Flight Escort magnets while they were on sale at 40% discount. She also placed a facebook question to members there asking whether they would like to order new magnets. An order was placed for two sample Club magnets and a subsequent order for 20 Club magnets 11.5 x 17.6 and 16 Honor Flight magnets of the same size. The total for both orders came to \$512.73. A motion was made by Bruce, seconded by Julie for the Club to pay for these magnets. All present voted in favor of the motion.

A discussion was then held on how to distribute these new magnets. Members that ordered new magnets are those that have attended the majority of the events this summer where the magnets could be used. Three options for distribution were then discussed as follows: 1) Those members could be asked to pay the Club price for the magnets that they would then keep. 2) Those members could be asked to pay a reduced amount for the magnets with the Club picking up the rest of the cost. Or 3) As the car magnets are used at Club events to advertise for the Club, those members could be given magnets to keep in their possession but could be asked to return them if they should ever decide to leave the Club. It was further discussed that it is easier to have members keep track of their own sets of magnets rather than one member be responsible for bringing them to any event. A motion was made by Dan, seconded by Dennis, that those members that participate in Club events on a regular basis be given sets of magnets, at no cost to them, to be kept in their possession and used at the appropriate events. Members could be asked to return those magnets if they decide to leave the Club. All members present voted in favor of the motion.

Movie Night at the Strand: Bruce reported that he has not heard anything back from the owner, nor has he heard back from Harbor Freight on his donation request.

August Meeting Details: The August Club Meeting will be held on August 19th, 2 pm at Alan & Julie's camp in Altona. A motion was made by Evelyn, seconded by Andrea, that the Club pay for hot dogs, hamburgers, sausages and rolls for the event as usual. All members present voted in favor of the motion. Members planning to attend will be asked to let Jayne know to determine how much food to buy. Members will also be asked to bring a food dish to share with the group. Julie volunteered to make Michigan sauce, Evelyn will bring peppers & onions and a cobbler.

September Meeting Date: It was decided to change the September meeting date from Saturday, September 24th to Sunday the 25th. Monika & Brad offered to host that meeting at their home in West Chazy and we will plan to take a cruise for food after the 2 pm meeting.


