Meeting Highlights

Wine Cruise Weekend: Dick reported that he has signed the contract with the Ramada Inn in Watertown for \$89.00 per night including breakfast. Members should make their own reservations at 1-315-788-0700. Anyone planning to participate is asked to let Dick & Evelyn know so they can plan accordingly. The weekend will start on Friday, Sept. 15. Members will plan to meet at Nana's Convenience store at the corner

of Rte 11 and the Forest Road at 8 am. The usual plan is to visit 5 wineries and at least one distillery.

Paint 'n Sip Party: Monika reported that the event went well and that our group raised \$130.00 to donate to the Honor Flight. The money was given to Linda to write a check.

New Club Brochure and More Magnets: Jayne reported that the new Club brochure is now available. By executive decision, more magnets were ordered to be given to members that regularly attend the events where they are to be used. The Vistaprint bill for \$195.87 was given to Linda prior to this meeting date and Linda has written the check to cover it. Members present were encouraged to take some of the Club brochures to keep in their cars for use when needed. Monika asked whether it would be possible for the Club to make a refrigerator magnet listing Club meeting dates. After some discussion, it was decided that this

might not be practical because we sometimes needed to change meeting dates during the year.

Beer Cruise Suggestion: Joe is still interested in planning a beer tasting cruise. He suggests that we could plan to cruise Rte 9 to Lake Placid and Saranac Lake to visit a number of different breweries. Joe also explained that some of these craft breweries are now also making soda and apple cider. After some discussion, it was decided to incorporate this trip into the Fall Foliage Cruise already scheduled for Saturday, October 7th. Joe agreed to plan and lead the cruise.

Honor Flight Parade Requests: We have received escort request for three more parades. Miles suggested that we might try organizing our participation so that 5 or 6 cars might attend each event as possible. The next parade request is for the Mooers Labor Day parade on September 3rd. Of the members present, Miles, Dick & Evelyn and Lindsay expressed interest in participating. The Sept 9th Plattsburgh Parade coincides with the Lake George Car Show and the Sept 16th Peru parade is the same weekend as the Wine Cruise. This may eliminate some of our regular participation in those parades but there may be others still available to attend. Jayne will post a request for interest on facebook. Car Show 17 Review: we received many compliments on the new site, plenty of space and the weather was great. The locals seemed to enjoy having the show nearby. From the comment forms, we heard that there were some negative concerns about the food vendor, some would like to see more awards/trophies given, and a number of people had problems with the step at the tarmac for the registration & sales tents. Further comments from Club members included concerns about the location of the DJ as the sound did not carry well to the cars on the field.

Dick told us that a limited edition of a Show shirt will still be offered. Shirley showed us a sample of the shirt that will include a version of the dash plaque design on the front of the shirt and the Show Sponsors printed on the back. 35 decals are available for the shirts, including 13 that will be given to Show Sponsors as a thank you gift. 22 more shirts will be available by preorder only. The price will be \$20.00 each for sizes M- L- XL and \$22.00 for XXL. Jayne was asked not to make the preorder offer available in the September newsletter as the orders need to be gotten to Dick by the end of August. Dennis will post a picture and details on the website.

Linda presented a financial summary for the Show for our consideration. She explained that those numbers cannot be finalized yet as we do not have all the bills paid at this time. Most notably, we do not have the final Show Shirt cost to factor in. Dick explained that by charging \$20/\$22 per shirt, we hope to break even on the shirt cost with the sponsor gifts included. Miles noted that, by executive decision, he purchased 8 more folding chairs at the Malone K-Mart closeout sale after the show as we do not have enough chairs for the day of the show. After some discussion, it was decided that the Club should purchase an additional 4 chairs giving the Club a total of 24 folding chairs. The discussion further noted that we have to borrow at least 4 tables for the day of the show and that the Club's wooden table is in rough condition. A motion was made by Dick, seconded by Brad, that the club purchase 6 more six foot tables and 4 more folding chairs. All members present voted in favor of the motion. Dick will plan to purchase the chairs and Miles will purchase the tables.

Charity Donation Discussion: After some discussion on what the expected Club expenses might be over the next year, a motion was made by Dennis, seconded by Brad, that the Club donate \$2,000.00 to the North Country Honor Flight. All members present voted in favor of the motion. Linda wrote the check to be delivered.

Jim Honer spoke about what a wonderful organization the North Country Honor Flight is and how well they treat the Veterans on the flight day and throughout many other local events.

Car Show 2018: A vote was taken of the members present, as well as several active members not able to attend the meeting, on whether to plan a Car Show in 2018. 19 members voted in favor of the Show, 3 members voted against the Show and 2 members abstained from voting. Dick & Evelyn agreed to act as Car Show chairpersons again. The following members agreed to be on the committee: Shirley, Alan & Julie, Joe & Andrea, Linda & Bruce, and Dan

Andrea, Linda & Bruce, and Dan.

July 29, 2018 would be the date of next year's show. Dick will contact the City of Plattsburgh to determine the site – hopefully at the Oval once again.

Dennis brought a number of items for members to share.


