
**Treasurer's Report:** We have 2 renewals Maurice and Allyne Chartier and Jeff and Sue Moore.

**ARC Party:** The ARC Christmas party that used to be held in January has been changed! It will now become the ARC Spring Fling! Date to be determined.



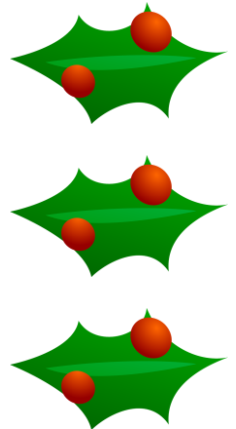
