Marine Corps League – What is Branding?

MARINES: Branding is the process of creating a distinct identity for a business / organization in the mind of a target audience or consumer. At the most basic level, branding is made up of a company's name and logo, visual design, mission, and



tone of voice. Branding is giving meaning to a specific organization, company, products, or services by creating and shaping a brand (a perceived image) in consumers' minds. Branding applies directly to the Marine Corps League (MCL) in what we do; how we look; how we conduct ourselves.

Consider a brand as the idea or image people have when thinking us as an organization, both in a practical way (e.g., "we are the only Marine Corps-specific vet-

eran service organization") and an emotional way (e.g., "sharing camaraderie and participating in detachment events make me feel whole.") It's not just the physical features that create a brand but also the feelings that members and prospective members develop towards the MCL or our product. This combination of physical and emotional cues is triggered when exposed to the name, the logo, the visual identity, or even the message communicated – BRANDING.

We use our MCL logo and MCL uniforms to create a unique brand identity, which helps distinguish us from other veteran service organizations. Our actions and mannerisms amplify that identity; especially when wearing our logo and uniform. This creates the physical identifiers of branding (which includes items such as business cards, banners, table coverings, detachment flags, etc.) We boast our

Heartland Young Marines Presented with Unit Commendation Award

MARINES: The Heartland Young Marines were presented with the Marine Corps League Unit Commendation Award in July 2023 at the Mount Vernon American Legion Post 141. The award is presented to a Young Marine unit for outstanding performance of duty to the community over an extended period, or for any single act when the unit has performed under great competition with other units or organizations.

The recognition is for all the community service that the Young Marines have done not only throughout Jefferson County, but in other counties, as well. It's really the Young Marines' accomplishment for coming out and doing all those community service hours. It is a great honor to get this national award from the Young Marines program in general.

This award consideration was submitted to the national headquarters by the Department of Illinois Marine Corps League Commandant Ronald Burns, Sr. and Senior Vice Commandant Randy Weber for the unit serving the community at 59 community events totaling over 210.5 volunteer hours from 2017 – 2022.

The Marine Corps League Unit Commendation award is the highest service award a Young Marines unit can receive. It is given to Young Marines organizations for their dedication to the community and to the Marine Corps League as a whole. Weber said that he believes it shows

a lot of commitment, not only from the Young Marines, but also shows the hard work of the Young Marines staff John Kowalski and Eddie Vaughn and their families as well. The staff said that they're very thankful for the family support.

The community service over the past five years includes assisting with local Memorial Day and Veterans Day ceremonies, assisting organizations such as Healing of Our American Heroes (HOOAH), presenting to the Southern 30 Center, performing color guard and other ceremonial duties at various events and much more.

"To tell you it is not easy would be somewhat of an understatement, because it isn't," Kowalski said. "There are not a whole lot of Young Marines that get this. We are very pleased, very proud, and very humbled to receive this award."

The unit was presented the commendation ribbon with other awards due to this honor and the unit guidon was given a streamer to display the award.

What is the MCL Foundation?

The MCL Foundation is a 501 (c) (3) corporation which has received this designation from the Internal Revenue Service making contributions fully deductible.



The Foundation was established in 1989 with the specific purpose of centralizing MCL charitable contributions and as separate organization to conform with IRS regulations. The Foundation has a blocked scholarship fund providing scholarship aid to the children and grandchildren of deceased Marines, as well as the children and grandchildren of MCL members. Humanitarian assistance is granted to individual Marines and their families who have fallen upon hard times. The form for seeking this assistance appears on the MCL Foundation's website.

We help fund a number of Marine Corps League youth programs

including the Young Marine Program and the MCL Youth Physical Fitness programs. As natural disasters have become a recurring part of contemporary life, we stand ready to provide assistance to Marines and their families.



JUNIOR PAST NATIONAL COMMANDANT

The Role of Junior Past National Commandant

MARINES: As I have done in the past as I moved on to another chapter of my Marine Corps League leadership travels, I want to share what it means to be the Junior Past National Commandant. At the end of our 2023 National Convention, I had a Marine ask me what's now for me and exactly what are the responsibilities of the Junior Past National Commandant. I thought for a few minutes and gave a basic answer, "Whatever the national commandant needs me to do and to be there to support him."

Although this is basically true, the job goes a little beyond that. The national bylaws only state that the junior past national commandant shall be a voting member of the national board of trustees and that they shall preside at all past national commandants (PNC) council meetings. The junior past commandant at all levels should be the mentor to the commandant, be there whenever the commandant needs guidance or assistance, and always be there to support the board of trustees. Again, this same philosophy should be applied at the detachment, department, and national levels.

At the national level, there is one more important element of the responsibilities of the junior past cational commandant that I mentioned earlier. The "Past National Commandants' Council" is chaired by the junior past national commandant. The PNC Council is an advisory council which is an integral part of the national staff, composed of all past national commandants. The PNC Council is a collective advisory body and is charged with the responsibility of



providing assistance to the national board of trustees.

In general, the duty of this council or PNC society is to, when asked, execute in-depth study tasks as assigned by the national commandant or the national board of trustees through the council chairman. will be rendered. The PNC Council can collect or receive donations to support its objectives, i.e., grave markers for deceased past national commandants.

This position is extremely important at all levels of the League. These past commandants at the detachment and department levels should be a positive asset to the board of trustees. If they are allowed to use their experience and knowledge of the League in assisting the detachment or department, it will enhance their success. At the national level, the PNC Council is composed of Marines with many years of experience and leadership and can aid the national commandant and the board of trustees when requested. Dog Days Mean Big Bone Donations!



MARINES: Woof, Woof, to all the magnificent dogs of the MODD! To the 495 dogs at the 100th Anniversary Marine Corps League Convention and 83rd Supreme Growl in Oklahoma City, I hope you took advantage of some of the fun on tap for us there.

The local convention committee kicked off the fun Sunday with the Early Bird's Talent - No Talent Show. This entertaining event also kickstarted fundraising for the MODD's 2024 donation to a Children's Hospital in California.

Oklahoma Pack ramped things up with Dogs Day in the Park, which gave everyone an opportunity to bid on pies to throw at select MODD members or send them splashing into the dunk tank. We even had a group of young adults who wanted to join in the fun, pooling their bones to throw a pie at one of their crew.

The biggest Dogs Day splash was the \$74,000 big bones that kennel staff members presented on behalf of all you dogs to very appreciative representatives of the Oklahoma University Children's Hospital. Earlier in the day, we toured the hospital's impressive facilities and their team shared how the donation would benefit children coming from around the country for critical medical care. For all of you dogs active in fundraising efforts for the annual donation, as well as efforts to assist your local hospitals and other causes, BIG BARKS TO YOU ALL, keep up the fantastic work!

Now a little food for thought for all of the pounds and packs that have not been active in helping with the annual donations; we could do so much more for the kids if you jump on board with even a modest effort. The Missouri pack led the Kennel in donations this year with \$32,959 big bones with about \$10,000 going to a local Missouri hospital and the remainder to the Kennel Children's Hospital Fund. That was a combination from passport fees, along with the fundraising efforts of six different pounds as well as pack fundraising projects.

You and I know we can do even better without

breaking a sweat. If we had averaged just \$20 big bones for each of our 5,489 dogs of the MODD, this year's donation would have been almost \$110,000, vice \$74,000. Recognizing our amazing potential, the sky really is the limit with so many dogs who go above and beyond to help the children!

For a simple fundraiser, pounds might consider purchasing MODD yellow

roses at \$30 per gross. Many pounds invest in a couple gross

of roses, set up at a local retail store for three or more hours and bring in \$900 to \$4,500 in donations, while also sharing recruiting information! Some people donate pocket change, while others toss in \$1 to \$20 to help the kids. It can be just that easy and inexpensive to help the children

Of course, the MODD is about more than our efforts to help sick kids... we're also about the FUN! In addition to the activities above, we also had the chance to watch candidates for advancement as their handlers ran them through their paces this year. The platoon competitions always provide a bit of fun, although I may have seen kennel veterinarians tending to the ears of a couple past chief Devil Dogs after they judged the singing competition. All this was followed by a spirited Supreme Growl where we had fun and took care of business too!

Congratulations are in order for the 115 dogs who advanced in Oklahoma City. It was an honor to conduct your obligations – congratulations to each of you!

What do I wear to the Marine Corps Ball?

MARINES: It's the Marine Corps Ball and you don't know how you should dress. What do you do? First step, confer with the intention of the organizers. Is it a formal event? Is it a luncheon? Is it a casual atmosphere and casual dress – aloha attire? Your attire should always match the sentiment of the event.

In accordance with Marine Corps tradition, the Marine Corps Ball is a very formal event. Marines are to dress in their best uniform whether it is dress blue alphas (with medals), dress blue bravos (with ribbons and badges), or service green alphas (with ribbons and badges) – Marines are to dress in their best uniform. This sets the stage for the Marine Corps League (MCL) and those members attending local Marine Corps Balls.

The MCL evening dress/mess dress uniform is the most formal of all MCL uniforms. Comprised of the red, waist-length jacket and worn with either the dress blue trousers or tuxedo trousers, the MCL evening dress/mess dress uniform is also worn with a standard tuxedo collar shirt and standard (uniform size) bow tie and gold vest or the gold cummerbund. Female members will wear ankle-length, black



MCO 1020.34H MARINE CORPS UNIFORM REGULATIONS

The Marine Corps League, without a doubt, has the best looking uniforms of any veteran's organization. Our uniforms, like our counterparts on active duty in the Marine Corps, are practical, well-designed, and display an aura of professionalism.

When our Birthday Ball and other Veteran events occur, many like to wear their rightfully earned Dress Blue Uniform. We encourage all veteran Marines to uphold the MCO 1020.34H Marine Corps Uniform Regulations.

When wearing the Dress Blue Uniform please adhere to the MCO for personal appearance and grooming standards based on gender. If you will not follow the MCO, then please refrain from wearing the Dress Blue Uniform.









skirts. Only miniature medals are worn with this uniform, at the wearer's discretion, which are placed across the widest part of the lapel. Applicable collar emblems are worn on the red waist-length jacket, MCL sunburst (screw post) for regular members and MCL embossed gold bar for associate members.

The MCL formal dress uniform is a rendition of the red blazer and is similar to the MCL evening dress/mess dress with the exception of the red blazer; and the fact that the dress blue trousers are never worn with the red blazer. Male MCL members will wear black tuxedo style trousers and female MCL members will wear anklelength, black skirts. As with the MCL evening dress/mess dress uniform, miniatures medals are worn, at the wearer's discretion. Blazer crests are, typically, not worn when wearing the MCL formal dress uniform.

The MCL casual dress uniform is comprised of a red blazer with a white, standard button-front shirt with standard collar (not button down) and a standard black tie or a black neck tab. Black slacks or a knee length black skirt are worn with this uniform. Collar emblems are never worn on the shirt in this configuration, nor are they worn on the red blazer. Dress blue trousers are never worn with the red blazer. Miniature medals are never worn with this configuration; however, large medals may be worn, but no more than three large medals, mounted together. An easy piece to remember regarding large medals versus miniature medals are "large tie-large medals; small tie-small medals". Ribbons are never worn with the MCL casual dress uniform.

If you choose to wear formal attire and not the MCL uniform, a tuxedo or a formal gown, look your best. If you choose to wear miniature medals with your tuxedo, wear them with pride. The Marine Corps Ball is a grand event, regardless of what you wear, wear it with honor and distinction.

NAMED IN HONOR OF



Herbert A. Littleton Detachment #1261

erbert A. Littleton was born July 1st,1930 to Paul N. and Maude Littleton. Times were hard and money scarce. His family had to move to Port Orchard, Washington to work in the shipyards. Herbert and his family later moved to South Dakota where he attended school. Like many young men Herbert played football and basketball and was a popular student during his public-school days.

Herbert later was employed by the Electric Appliance Company in Rapid City, Dakota. However, he never lost touch with his rural values and country way of life instilled in him by his family.

With the advent of the Korean conflict, Herbert voluntarily enlisted in the Marine Corps. On July 29th, 1948, Herbert A. Littleton was sworn into service for his country. He completed recruit training at Marine Corps Recruit Depot, San Diego. Then he completed his training at Camp Pendleton. He was then shipped to Korea as part of the third replacement draft. As with many other young men of his time, he left behind his family and a girl with whom he planned to someday build a life with, have a family of his own and live the American dream.

Littleton fought in the Korean Conflict from December 17, 1950, until April 22, 1951. On April 22, 1951, PFC Littleton's battle ended, as did his life. PFC Littleton, U.S, Marine Corps Reserve, Company C, first Battalion,7th Marines,1st Marine Division (reinforced) was killed by a North Korean grenade at Changchun, Korea. While this is a tragic event, it is not what made Littleton a great example that can be called upon to lead us through hard times. Like most things, it is not the event alone that brings out the best in us, but how we choose to deal with those events.

For his selfless service to our country

Littleton was recognized and honored by being posthumously awarded the Medal of Honor.

Though he was born in Mena, Arkansas, until recently no memorial or other recognition has been established in Arkansas in memory of this gallant native son. This situation was rectified at 10:00 a.m. Saturday,12 September 2009 at the Polk County Courthouse, Mena, Arkansas. At this time and date, a memorial was unveiled to honor Littleton.

The memorial is the result of a grass root movement spearheaded by the Herbert A. Littleton Detachment 1261 of the Marine Corps League, Mena, Arkansas. With the support of the citizens of Mena and surrounding Polk County and others from outside the area, funds have been raised to build this monument to our fallen comrade. This memorial stands proudly in memory of our native son. Semper Fi!

Out of your Comfort Zone

MARINES: I cannot tell you what convinced me to join the United States Marine Corps when I was drafted in 1969, but I did. It all happened in a matter of less than 90 seconds.

A Marine Corps Staff Sergeant centered himself in front of all the men who passed the physical at the induction center. Hands on hips, feet shoulder width apart, with creases so sharp in his shirt and trousers that they could cut you. He had a stare that would cause fresh milk to curdle, dogs to run, and women to cry. With the voice of a chain smoker who shouts every word, one octave below deep, he states, "I need two warm bodies for my Marine Corps. One with a strong back, and one with a strong mind."

What in the hell was I thinking when I raised my hand. I really don't know. I had neither one. I do know the only time I ever

regretted it was in boot camp. I had a leg injury that limited my ability to run, but that didn't stop me from pushing it to the limits. Everyone was pushed to the limits. We were told that we would go through training in under nine weeks. They needed warm bodies in Vietnam. Now, that was encouraging to hear. No training would be sacrificed, only our sleep. What was supposed to be thirteen weeks of boot camp was cut to under nine weeks.

So, where am I going with this? You never know what your limits are unless you go there occasionally. Getting out of your comfort zone and trying something new will not kill you (hopefully) and may make you a better person. I was definitely out of my comfort zone for those nine weeks in 1969.

When I joined the Marine Corps League, I was out of my comfort zone. I knew nothing about the hierarchy, policies, or procedures. I had been to three meetings and was suddenly the adjutant. I was definitely out of my comfort zone. A year later I was the judge advocate (what do you mean I have to rewrite the bylaws?) Then junior vice and on to senior vice and detachment commandant. I never went into a position in the League that was within my comfort zone. Each had its challenges and its responsibilities.

Step up and accept the opportunity to be more than the person you thought you could ever be. You have the entire Marine Corps League behind you. You cannot fail. After all, you are a Marine. **Semper Fi!**

Don't Overlook These Great Recruitment Tools





MARINES: One of the ongoing challenges we have in the Marine Corps League lies in our ability to attract younger members. Those who have recently left active duty have generally shifted their focus to careers and family. We often overlook some of our existing programs that can provide benefits to our members by engaging their entire family. In addition to planning periodic detachment meetings where family members are invited, there are more formal programs that offer total family benefits and can serve as powerful recruiting tools. Here are some:

MCL Scholarship Program Each year, nearly 200 applicants are awarded a cash scholarship. They may receive the award for up to four years while pursuing an undergraduate degree. These are not competitive scholarships; the student must have attained at least a 3.3 GPA, enroll for a minimum of 12 credit hours per semester, and be

sponsored by a League, or an auxiliary member in good standing. Recipients may be the member, a spouse, children or grandchildren. It's a good return on the investment of League dues, and should serve as a powerful incentive in attracting and retaining members. As an aside, detachments have been encouraged to contribute to the MCL Foundation to help fund this program, which last year amounted to \$109K in scholarships.

Young Marines Here is another program especially attractive to members with younger kids. While they don't need to be League members to participate, Marines can employ their pride and skills to teach 8- to 18-year-olds the values patriotism, teamwork and anti-drug use. This can be a valuable experience for the adult leaders as it is for the Young Marines. League member participation in this program is not only great for community relations, it helps strengthen the bond between the member and the family.

Youth Physical Fitness This is a League-owned program that is administered by schools. League members can help by calling on schools to help persuade them to adopt the program, then participate by assisting at events. Again, it demonstrates the value of the League while providing benefits to the member's family and the community.

By ramping up our focus on these youth programs, we can offer League members not only the opportunity to share in our camaraderie and values as Marines, but we can do it while extending the chance to further their involvement with their kids and family. These are great value-adds we can offer. They are also greatly overlooked recruiting opportunities.

wenty-two American service members and veterans commit suicide every day. Suicide prevention is a problem without a clear answer. Veterans need a variety of resources to combat the latent stress, anxiety, and depression that can often follow their service to our country. It is not emotional issues alone that contribute to veteran suicide. Often family, home, and employment problems are contributing factors. Providing veterans with a wide range of resources to fight issues they are working through is crucial to healing.

Organizations are taking action to make an impact on those that need our support. In 2022, the Memorial Day Detachment # 468, Marine Corps League (Department of New York) and American Legion Post 256 of Canandaigua, New York teamed up to host a suicide pre-

vention and awareness event at the Legion post. In 2023, the event has grown to a coalition consisting of the American Legion, American Veterans (AmVets), Marine Corps League (MCL), Veterans of Foreign Wars (VFW), and Vietnam Veterans of America (VVA).

The 2023 event featured a two-mile walk, car show, food trucks, live music,

silent auction, and even a motorcycle ride around Canandaigua Lake. We had selected four local organizations that provide services to veterans that help to prevent depression and other issues that may cause an individual to contemplate suicide. All organizations had representatives present at the event to provide information and answer questions.




