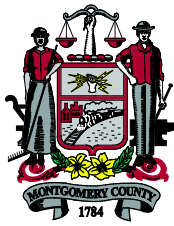

(Please do not complete or make payment until you have met with park staff. Date, time and location must be pre-approved.)

Fee Schedule & rules:

- less than 50 people (same as photo session) \$50
- 50-100 people, (no additional photographer fee) County resident \$100, non-resident \$150
- 100-150 max., (no additional photographer fee) County resident \$200, non-resident \$250
(The above fees are the same as those for a Special Use Permit.)
- Tents larger than 10' x 20' are prohibited.
- Chairs, runners, trellises, planters, etc. must be set up and taken down the day of the event.
- Only picnic style receptions are permitted. **Alcoholic beverages, caterers, bands, DJ's, loud music, are prohibited.**
- Fees are non-refundable, no matter what the weather or park conditions.
- Checks may be made out to "County of Montgomery."
