By making a payment and completing your reservation you acknowledge, understand and agree to the terms and conditions outlined herein. Please be advised that all payments made to Marry Me Philadelphia are non-transferable and non-refundable.

## Arrival

Couple and guests (when applicable) must arrive within 10 minutes of scheduled appointment time. Early and late arrivals of more than 10 minutes usually cannot be accommodated. If you find you will be late, contact your officiant via text (so as not to interrupt other events via telephone) as soon as possible. Please see below for location-specific details.

<u>Late fee</u>: \$25 every 15 minutes after your scheduled start time. Late fee must be paid prior to signing of license/appointment. Late arrivals are not guaranteed entry and may be subjected to cancelation or rescheduling. If rescheduling, a rescheduling fee will apply. Please see <u>Terms of Service</u> for more details.

## Marriage License (does not apply to vow renewals)

- Couples marrying in Pennsylvania must obtain a marriage license from any issuing county in PA regardless of residence or county wedding will take place in.
- It is the responsibility of the couple to obtain the marriage license at least 3 days prior to wedding day. The license is valid for 60 days.
- Couple must furnish a printed marriage license from the county. Marry Me Philadelphia cannot guarantee the ability to print documents on behalf of the client unless previously arranged.

Due to the pandemic, effective 6/2020, couples must mail back the "duplicate certificate" portion of the marriage license to the applicable county. Couples must contact the county directly to obtain the certified marriage certificate.

Lost documents: Marry Me Philadelphia will not be held liable for any lost documents. In the event the county does not receive your documents, please contact the county directly to obtain a copy of your documents. There will be a \$100 fee for the processing of additional documents after wedding day.

It is imperative that you arrive at your designated time. Please arrive on time, no more than 10 minutes before or after your scheduled start time.






## Location
