This is a new tool for your tool kit. This document is for those of you who have served Stand United's Informed Consent package. These follow-up questions can be used in three different ways: by asking in person, by sending through mail or email.

1. Do you know what Informed Consent is? (If they cannot explain it, read the definition to them).

Informed consent is the act of agreeing to allow something to happen, or to do something, with a full understanding of all the relevant facts, including risks, and available alternatives. That full knowledge and understanding is the necessary factor in whether an individual can give informed consent. This type of consent applies to many situations in life, including making decisions about medical care and legal issues, as well as entering into contracts.

Consent is given only if that person has been informed of, and understands the facts of the situation, with a full comprehension of the risks and benefits of the decision, as well as an understanding of the possible alternatives, that any individual can consider whether an action would be in his best interests.

Obtaining of informed consent is especially important in the medical field, as failing to receive such approval leaves medical professionals liable for injuries that may occur

- 2. Do you still feel as though the public has been appropriately informed?
- 3. Are you going to protect the people from those that are causing harm due to improper Informed Consent? If yes, how? If no, why not?
- 4. Do you understand that "mandatory" removes "voluntary" which also removes informed consent?
- 5. All immunizations in Canada are voluntary and cannot be mandated under of the Canadian Constitution; are you aware that those rights have been violated and it is your duty to uphold lawful orders?
- 6. "No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment. In particular, no one shall be "Subjected without his free consent to medical or scientific experimentation." Are you aware that The Covenant on Civil and Political Rights (1976) under Section 7 has been violated?

- 7. Under this Covenant, both Pfizer and Moderna have admitted that this is an experimental drug. Are you going to uphold the law that what is being done is unlawful and cruel punishment for those that have been subjected to this?
- 8. Criminal Code violations have occurred, they are, but not limited to:
 - Intimidation Section (423)
 - Extortion Section 346
 - Assault Section 265
 - Assault Causing Bodily harm Section 267
 - Administering noxious thing section 245
 - Breach of Trust Section 336
 - Disobeying a stature Section 126
 - Public incitement of Hatred Section 319
 - Willful promotion of Hatred Section 319
 - Duty of persons undertaking acts dangerous to life Section 216
 - Duty of persons undertaking acts Section 217
 - Criminal negligence section 219
 - Causing bodily harm by criminal negligence Section 221
 - Homicide Section 222
 - Unlawfully causing bodily harm Section 269

Are you aware that during this time, law enforcement has not followed up on, but rather, supported these violations?
