

Good day,

Before you are envelopes with documents addressed to each of you. These documents contain scientific research from CDC, Pfizer, Moderna, VAERS and CAERS, expert virologists, epidemiologists, respiratory specialists, lawyers, and psychologists as well as references to the Canadian Charter, legal precedents, and the Nuremberg code outlining laws that have been broken over the past two years.

On page 3 under your name, you will note the statement:

“Notice to Agent is Notice to Principle, Notice to Principle is Notice to Agent”

The statement means this notice obliges you to share this letter and the contents of this package with every person above and below you in your chain of authority within your workplace and/or organization. It is incumbent upon you to provide the information contained herein to any person requesting information from you on the topic of Covid 19 vaccinations, masking, and testing so that they may make fully informed decisions. It is also incumbent upon you to be aware of this information in the event there is any further expectation or inclination to attempt to demand employees or residents share their personal & private medical information in order to retain their employment or make use of facilities that are meant to be accessible to the public.

By supplying you with this information we trust that the intense experiences we all lived through over the past two years will never happen again. We expect that you take the time to read through the documents and familiarize yourself with the information enclosed. It is a **Notice of Liability** and is the first step in a process to ultimately hold accountable all those who created, implemented, marketed, influenced, administered, and perpetrated unlawful, unethical and unconstitutional mandates which proved to have catastrophic effects on our communities.

Part of this NOL is a reminder to those in authority of the existence and definition of informed consent.

For those of you who don't know, **informed consent** is an ethical and legal principle that ensures our autonomy and right to make decisions regarding our health which must be “free of undue influence, duress or coercion in making the decision”

(<https://cpsa.ca/physicians/standards-of-practice/informed-consent/>). Its purpose is to affirm a person's rights to determine what happens to their bodies and it upholds your duty to provide accurate and sound information to make an informed decision.

Consent must be:

- **Voluntary,**
- **given by someone with the capacity to consent,**

- **given by a person who is properly informed, and**
- **Freely given.**

Our courts have reaffirmed repeatedly our right to refuse treatment even when it is their opinion the treatment is necessary to preserve our life or health. When explaining the consequences of refusal, those who are explaining the consequences **must NOT create a perception of coercion in seeking consent.** <https://www.cmpa-acpm.ca/en/advice-publications/handbooks/consent-a-guide-for-canadian-physicians#requirements>

In closing, now that you have the documentation and notice of liability in hand we ask that you provide a response to the following questions in the next two weeks:

- Have you read the package and availed yourself of the scientific and legal information therein?
- Did you share this package and information with above and below your chain of authority?
- Having read this information will you now make ALL information therein accessible to the public as you did with the non-peer reviewed and biased statements from all levels of government during the last two years?
- Because informed consent must be free of coercion or any appearance of coercion, will you commit never to attempt to coerce or appear to coerce those within your authority or influence?
- Will you issue a letter of apology to those who were misled by your support and implementation of the REP program & discriminatory mandates?

We will be following up with a reminder of these questions and respectfully expect a clear response to them within two weeks.
