FREQUENTLY ASKED QUESTIONS NEW WATER & SEWER RATES AND FEES

- Q. What is a rate study?
- A. A rate study evaluates what a utility is charging for services and rates (user fees) and compares that revenue to the cost of providing water and wastewater services to its customers now and into the future. The rate study also examines how the fees compare to what other local utility systems charge. Rate studies also examine impact fees, the one-time charge paid by customers who are requiring increasing system capacity, to ensure that new development is paying for itself and not on the back of existing customers.
- Q. Why is a rate study being done?
- A. IRCDUS knows it can't continue under the current rate structure. IRCDUS wouldn't be able to make repairs, replacements, or rehabilitate aging infrastructure and this would negatively affect their ability to continue providing safe and reliable services. IRCDUS must evaluate the adequacy of rates and fees compared to the cost of its operations and future facility needs.
- Q. Why are rates going up?
- A. IRCDUS operations and capital improvements, which includes building new facilities and upgrades to existing systems, are funded exclusively through user fees (not through taxes). To ensure it can continue providing safe and reliable service for residents and businesses, IRCDUS is conducting the rate study to ensure its rates and fees generate sufficient revenue to satisfy ongoing operational, maintenance, renewal and replacement, system expansion, and regulatory requirements.
- Q: When will the new rates take effect?
- A: The initial rate increases will come into effect, January 1, 2025, and a second round of rate increases will take effect October 1, 2025
- Q: What are the new water rates?
- A: The new water rates are as follows:




Q: How will my average bill change with the new rate?
