Cancellation and Refund Policy

Rejection: An applicant rejected by the school shall not be obligated by this contract and all monies paid will be refunded.

Termination Date: The termination date for refund calculations is the last day of attendance.

Three-Day Full-Refund Policy: This begins upon completion of the following:

1. Signature of the Applicant
2. Initial payment by Applicant with acceptance by the School
3. Signature of the School Official

All monies paid by an applicant will be refunded if requested within three days after signing an enrollment agreement and making an initial payment. Upon expiration of this three-day full-refund policy, the Applicant is bound by the Enrollment Agreement (contract).

Other Cancellation: An applicant subsequently requesting cancellation shall be refunded all monies paid minus a registration fee of 15% of the contract price of the course; not to exceed \$250.

Refund Policy

First Week: For a student terminating training; 1) after the three-day cancellation period, 2) after entering school, and 3) after starting the course of training, but within the first week, the refund to the student shall be 90% of the contract price of the course minus \$250; not to exceed \$500, which is deducted from the original contract price.

After First Week: For a student terminating training after one week but within the first 25% of the course, the refund shall be 50% of the contract price of the course; minus \$150.

After 25%: For a student terminating training after completing over 25% of the course will not receive a refund.

Thirty-Day Refund: Any refund or other monies due the student shall be refunded (paid) within thirty days (30).

Special Cases: In case of student prolonged illness or accident, death in the family, or other circumstances that make it impractical to complete the course, the school shall make a settlement which is reasonable and fair to both.

Discontinued Class: If a class is discontinued by a school while students are still enrolled in that class, and the school is still offering training in other areas, all monies (student loan, grant, and etc.) paid the school for students enrolled in the class at the time it is discontinued shall be refunded to the entity legally entitled to the refund. The school shall have 30 days to restart the class or pay all refunds.

The Holder in Due Course Rule: Any holder of this consumer credit contract is subject to all claims and defenses which the debtor could assert against the seller of goods or services obtained pursuant hereto or with the proceeds hereof, recovery hereunder by the debtor shall not exceed amounts paid by the debtor hereunder.
