Disruptive behavior, gossip, or disrespect toward staff or fellow boarders may result in termination of this agreement.

### 4. Owner Responsibilities

- Ensure vaccination and deworming are up to date
- Supply any special feed, supplements, or medications
- Maintain liability insurance (recommended)
- Notify Stable of any changes in health or behavior

### 5. Liability & Risk

The **Owner** understands that equine activities carry inherent risks. Honest Desires Farm is not liable for injury, illness, theft, or death of boarded animals, except in cases of gross negligence.

The Owner acknowledges that black walnut trees are present on the property. These trees have coexisted with resident equines for over eight years without incident. While the **Farm** takes reasonable precautions to ensure animal safety, the **Owner** understands the potential risks associated with black walnut exposure and agrees not to hold the **Farm** liable for any health issues that may arise with the trees.

### 8. Barn Rules

To ensure a safe, respectful, and peaceful environment for all:

- **No drama**: Gossip, bullying, or disruptive behavior will not be tolerated.
- **Respect the animals**: Do not feed, touch, or handle animals that aren't yours without permission.
- No stallions or breeding: We do not accept stallions or offer breeding services at this time. All boarded animals must be geldings or mares.
- Gate & fence safety: Always close gates securely and report any damage.
- Clean up after yourself: Dispose of trash, feed bags, and manure properly.
- **Visiting hours**: 8:00 AM to 8:00 PM daily. Please do not visit outside these hours unless pre-approved.
- Communication: Notify us of any concerns or changes in your animal's health or behavior.
- Children: Must be supervised at all times.
- No dogs: For safety and biosecurity, dogs are not permitted on the property under any circumstances.
- No smoking anywhere on the property.
- Events & guests: Please ask before bringing guests or hosting any gatherings.

Failure to follow barn rules may result in termination of boarding privileges.
