- 1. <u>60 DAY NOTICE</u>: This notice of election of the Board of Directors is provided not less than 60 days from the date set for the election, or no later than Thursday, September 14, 2023.
- 2. <u>40 DAY NOTICE OF CANDIDACY</u>: If you desire to be a candidate for the Board of Directors, you must provide a written statement to the Board at the address above on or before 40 days before the date of the election, not counting the day of the annual meeting. The statements should be received not later than 5:00 p.m. on, Wednesday, October 4, 2023.
- 3. <u>35 DAY INFORMATION SHEET</u>: If you choose, an information/biography sheet or statement of why you want to be on the Board, must be provided to the Association not less than 35 days prior to the annual meeting. This sheet shall be on no more than one side of an 8 ½ x 11 sheet and received not later than 5:00 p.m. on Monday, October 9, 2023.
- 4. 14 DAY SECOND NOTICE: Not less than 14 days before the annual meeting and election, the Association will mail a second notice of election to all unit owners entitled to vote together with a BALLOT which shall list all the candidates in alphabetical order. If provided, the information/biography sheet or statement of a candidate will be included in the mailing. Since the Board will be voting on the budget at the annual meeting, the second notice will be mailed 30 days prior to the meeting, no later than Saturday, October 14, 2023.
- 5. At the annual meeting, no quorum is necessary for the counting of the ballots and declaration of the new Board of Directors. However, for an election to be valid, at least 20% of the eligible voters must cast a ballot. If this threshold is not met then a new election must be immediately commenced. A quorum of the majority of owners is necessary to hold an annual meeting for conducting other business.
