Dean seconded the motion. The motion passed unanimously.

MANAGEMENT REPORT –

- A. Legal Issues None at this time.
- B. Maintenance
 - <u>Landscaping</u> The landscaping by the signs will be completed next week. The tree trimming is complete.
 - Railroad Ties Further replacement on hold, will be trying to clean them.
 - <u>Shut-off Valves</u> On hold. After further inspection G&S Plumbing provided quotes to replace shut-off valves in six units for a total cost of \$9,275. This is way too costly and we are recommending we wait until we start doing the repiping.
 - <u>Laundry Room Equipment/CSC</u> Jose has been doing inspections and Jose will be doing one this week and input it into the website. Ken has been working on this and CSC has refunded \$279.00.
 - 3282, 3286 Will be getting gutter company to move downspout at 3286.
 - Stop Sign One more is needed by 3240 area that Tracy will order.
 - Year End Audit Requested quote from Bernie Mapili; however, he said that he
 cannot guarantee the audit to be completed timely either. There are not a lot of
 CPA's that do association year end stuff and they are all bogged down. Also need
 one more quote and cost from current CPA.
- C. <u>Violations</u> On-going, nothing major at this time.

COMMITTEE REPORTS

A. <u>Recreation Committee</u> – We now have a 3rd member from Club Villas. Attorney letter being sent to the subs about this issue.

OLD BUSINESS

- A. <u>Insurance Appraisal</u> Dreux Isaac & Associates quote for the insurance appraisal was updated to \$2,600 and they will not be available until January 2024. Ken moved to have them do a new appraisal and approved the increased quote. Dean seconded the motion. The motion passed unanimously.
- B. Roof Replacement 3252/3254/3296/3298 An updated quote from Total Roof was provided. On hold for additional quotes and consider a roof consultant to advise.
- C. Railroad Ties The invoice from Hartman was provided as well as the additional cost to finalize the project. Discussion ensued and the Board would like the attorney to advise the Board on how to resolve the overage in the contract. Ken asked for a conference call with the attorney and management.

NEW BUSINESS
