- Pool needs to be painted for \$18,000-20,000 (tabled until 2025)
- Continued discussion of needed dues increase of \$100 per household (adding \$33,200 to operating income)
- Tree project at 136<sup>th</sup> entrance \$15000 (tabled until late 2024 or 2025)
- Grounds maintenance contract fixed for 2023, 24, 25)
