- 3 Year contract was signed last week by Shane
- Decision on the next 3 years + Tree removal & new trees planted at 136th entrance
  - \$8,498 all in with labor for Trees | Royal Raindrop Crabapple
    - Also Raspberry Spear as an option
  - \*Need to decide on this – will proceed and will request fuller/bigger trees similar to what we got on the Springmill entrance; willing to pay a bit of a premium to get bigger trees
- Middle entrance wall is the best place for a larger planter. Spigot directly behind each wall at both entrances, and wouldn't have to drastically trim back trees if it was placed on east or west entrance.
  - Will request quote on the planters
- Did GI overseed the area around the entry to the pool?

**Pool Report – Amy Sullivan**

- Security light issue has been completely resolved.
- Replaced lights in boys and girls bathroom with LED lights. Had continued prior issues with older style, this should resolve moving forward
- Shane installed new locks on the back doors in each bathroom. Old locks were virtually not useable / able to be re-locked.
