



MARTIN'S ROD & CUSTOM FULL TURNKEY PROJECT

Below, you will find your expected timeline and chain of events.
Your estimated time to a complete Full Turnkey Project is 6 to 18 months.

STAGE 1: VISUAL INSPECTION AND ESTIMATE

- Martin's will provide a preliminary estimate based on parts and labor for your needs and concerns.
- Upon visual inspection, we will document all your information in writing and take pictures. We will provide you with a verbal second estimate.
- Once the estimated cost is agreed upon and signed, we will collect a down payment of funds required to cover parts and labor through stage 3.
- Parts will be ordered and received.
- We will schedule with you for arrival or transport of your vehicle to Martin's.

STAGE 2: TEAR DOWN

- At this stage, we will remove all parts required and recalculate our estimate if there are unforeseen issues. We will invite you in, or if you prefer, Facetime with you to review the list of suggestions and present our new updated estimate.
- We will continue to send pictures, schedule in-person reviews or Facetime with you to review work as requested.

STAGE 3: CHASSIS

- 1/4 of the way through the project, we will order the next phase of parts needed.
- We will perform a quality control check of all work performed.
- We will continue to send pictures, schedule in-person reviews or Facetime with you to review work as requested. We will also perform a review of our estimate with emphasis on the next stage.
- Once the estimated cost is again agreed upon and signed, we will collect a payment of funds required to cover parts and labor for stage 4.

STAGE 4: HEAVY FABRICATION

- Martin's will perform a double check and quality control checklist on chassis.
- We will continue to send pictures.
- Additional needed parts will be ordered and received.
- Your vehicle will have all fabrication work completed and will be passed, again through our quality control checklist.
- You will be invited to schedule an in-person review for a show of progress and to discuss the budget.
- At this point, we will make any adjustments to the budget and invoice and collect payment through stage 5.

STAGE 5: BODY AND PAINT

- Martin's will perform a double check and quality control checklist of all fabrication.
- We will continue to send pictures.
- Additional needed parts will be ordered and received.
- Body work will be completed and made ready for paint.
- You will be invited to schedule an in-person review for an update on progress and to choose paint color(s).
- We will review the invoice to date and accept payment if required.

STAGE 6: INTERIOR AND ASSEMBLY

- Martin's will perform a double check and quality control checklist on all fabrication and body.
- We will continue to send pictures.
- Additional needed parts will be ordered and received.
- You will be invited to schedule an in-person review for an update on progress and to choose from interior fabric and color options.
- We will review the invoice to date and accept payment if required.
- Complete Interior and Assembly.

STAGE 7: FINAL ASSEMBLY

- Martin's will perform a double check and quality control checklist for Interior and Assembly.
- We will send pictures and updates.
- All assembly items will be completed.

STAGE 8: TEST DRIVE AND DELIVERY

- Once all agreed vehicle repairs and upgrades are complete, we will send the vehicle through our Quality Control Checklist and provide a light cleaning. We will take pictures.
- You will be invited in to review and test drive the finished vehicle. (We can also arrange to deliver the vehicle and test drive at your location.) Final payment is now due.
