3. <u>Notice of Meeting – Nassau Herald:</u>

The Clerk reported that notice of the public meeting was emailed to the Nassau Herald and was posted on the bulletin board outside of Village Hall and in the lobby of Village Hall, and on the Village Website.

4. Minutes –October 27, 2022

On motion by Deputy Mayor Hirmes seconded by Trustee Hoschander, and approved unanimously, the Board dispensed with the reading of the minutes of the Board's October 27, 2022 meeting, as the Clerk had previously mailed such minutes to the Board members, and they are hereby approved.

5. <u>Public Hearing for Proposed Law WDS-2203</u> A local law to amend the Code of the <u>Village of Woodsburgh to authorize the use of videoconferencing for public bodies</u>

The Mayor opened the public hearing. The Village Attorney explained the proposed local law. The Board confirmed that the hearing notice was published in the Nassau Herald and posted on the bulletin board outside of Village Hall and in the lobby of Village Hall and Village Website. Affidavits of posting and publication of the hearing notices are on file at the Village Clerk's office, and hearing no comments from the public, on motion duly made by the Mayor, seconded by Deputy Mayor Hirmes, and adopted unanimously, the Board closed the public hearing and adopted the following resolution:

RESOLVED, that the Board hereby finds and concludes that (a) Proposed .Law WDS-2203 is an Unlisted Action under the State Environmental Quality Review Act and its regulations;

- (b) the Board is the lead agency with respect to environmental review of this proposed action:
- (c) the Board has considered the following factors in respect to its review of the environmental impacts of the proposed action:
- (i) whether the proposed action would result in any substantial adverse change in existing air quality, ground or surface water quality or quantity, traffic or noise levels, nor any substantial increase in solid waste production, nor create a substantial increase in the potential for erosion, flooding, leaching or drainage problems;
- (ii) whether the proposed action would result in the removal or destruction of large quantities of vegetation or fauna, substantial interference with the movement of any resident or migratory fish or wildlife species, impacts on a significant habitat area, substantial adverse impacts on a threatened or endangered species of animal or plant, or the habitat of such a species, or other significant adverse impacts to natural resources;
- (iii) whether the proposed action would impair the environmental characteristics of any Critical Environmental Area;
- (iv) whether the proposed action would conflict with the community's current plans or goals as official approved or adopted;
- (v) whether the proposed action would impair the character or quality of important historical, archeological, architectural or aesthetic resources or of existing community or neighborhood character;
- (vi) whether the proposed action would result in a major change in the use of either the quantity or type of energy;
- (vii) whether the proposed action would create a hazard to human health;
- (viii) whether the proposed action would create a substantial change in the use, or intensity of use, of land, including agricultural, open space or recreational resources, or in its capacity to support existing uses;
- (ix) whether the proposed action would encourage or attract large numbers of persons to any place for more than a few days, compared to the number who would come to such place without such action;
- (x) whether the proposed action would create changes in two or more elements of the environment, no one of which would have a significant impact on the environment, but when taken considered together would result in a substantial adverse impact on the environment;
- (xi) whether the proposed action would create substantial adverse impacts when considered cumulatively with any other actions, proposed or in process;
- (xii) whether the proposed action would result in substantial adverse impact with respect to any relevant environmental consideration, including noise, aesthetics, traffic, air quality, water quality or adequacy of water supply, drainage, soil conditions, or quality of life in the community in general and the immediate neighborhood in particular;
- (d) the proposed action, would not have a significant adverse environmental impact, as that impact is considered under SEQRA; and
- (e) no further environmental review is required with respect to the proposed action, and

BE IT FURTHER RESOLVED, that the Board adopts Proposed Bill WD-2203 as Local Law WDS-3-2022, and directs the Village Clerk to file Local Law WDS-3-2022 with the New York Secretary of State and take all actions required by law.

6. <u>Public Hearing for Proposed Law WDS 2204-a local law to amend the Code of the Village of Woodsburgh, to prohibit construction on Saturdays</u>

The Mayor opened the public hearing. The Village Attorney explained the proposed local law. The Board confirmed that the hearing notice was published in the Nassau Herald and posted on the bulletin board outside of Village Hall and in the lobby of Village Hall and Village Website. Affidavits of posting and publication of the hearing notices are on file at the Village Clerk's office, and hearing no comments from the public, on motion duly made by the Trustee Hoschander, seconded by Trustee Rosenberg, and adopted unanimously, the Board closed the public hearing and adopted the following resolution:

RESOLVED, that the Board hereby finds and concludes that

- (a) Proposed .Law WDS-2204 is an Unlisted Action under the State Environmental Quality Review Act and its regulations;
- (b) the Board is the lead agency with respect to environmental review of this proposed action;
- (c) the Board has considered the following factors in respect to its review of the environmental impacts of the proposed action:
- (i) whether the proposed action would result in any substantial adverse change in existing air quality, ground or surface water quality or quantity, traffic or noise levels, nor any substantial increase in solid waste production, nor create a substantial increase in the potential for erosion, flooding, leaching or drainage problems;
- (ii) whether the proposed action would result in the removal or destruction of large quantities of vegetation or fauna, substantial interference with the movement of any resident or migratory fish or wildlife species, impacts on a significant habitat area, substantial adverse impacts on a threatened or endangered species of animal or plant, or the habitat of such a species, or other significant adverse impacts to natural resources;
- (iii) whether the proposed action would impair the environmental characteristics of any Critical Environmental Area;
- (iv) whether the proposed action would conflict with the community's current plans or goals as official approved or adopted;
- (v) whether the proposed action would impair the character or quality of important historical, archeological, architectural or aesthetic resources or of existing community or neighborhood character;
- (vi) whether the proposed action would result in a major change in the use of either the quantity or type of energy;

- (x) whether the proposed action would create changes in two or more elements of the environment, no one of which would have a significant impact on the environment, but when taken considered together would result in a substantial adverse impact on the environment;
- (xi) whether the proposed action would create substantial adverse impacts when considered cumulatively with any other actions, proposed or in process;
- (xii) whether the proposed action would result in substantial adverse impact with respect to any relevant environmental consideration, including noise, aesthetics, traffic, air quality,

water quality or adequacy of water supply, drainage, soil conditions, or quality of life in the community in general and the immediate neighborhood in particular;

- (d) the proposed action, would not have a significant adverse environmental impact, as that impact is considered under SEQRA; and
- (e) no further environmental review is required with respect to the proposed action, and

BE IT FURTHER RESOLVED, that the Board adopts Proposed Bill WDS-2204 as Local Law WDS-4-2022, and directs the Village Clerk to file Local Law WDS-4-2022 with the New York Secretary of State and take all actions required by law.

7. MCS Security Consultants Increase Proposal

On motion by Deputy Mayor Hirmes, seconded by Trustee Rozenberg, and unanimously carried, the Board agreed to an increase in payments of 8% for MCS Security Consultants Inc. to commence on March 1, 2023, and authorized the Mayor to execute a contract providing for such increase.

8. <u>Proposal for Emergency Back Up of Snow Removal</u>

South Shore Building Maintenance Corp \$500 per hour per truck \$195 per yard of salt

On motion by Deputy Mayor Hirmes, and seconded by Trustee Rozenberg the Board unanimously voted to accept the back-up Snow Removal Contract from South Shore Maintenance Corp. provided all necessary insurances are in place as required by the Village, and authorize the Mayor to execute an agreement proposal, as approved by the Village Attorney.

9. Woodmere Fire Department Agreement

On motion by Deputy Mayor Hirmes, seconded by Trustee Rozenberg and unanimously approved, the Board voted to hold a Public Hearing on December 19, 2022 at 7:00 pm, with respect to the Woodmere Fire Department Contract, and directed the publication of the required legal notice.

10. Flower Baskets for 2023 Fiscal Year Bayport Flower House \$3808

On motion by Trustee Hoschander, seconded by Trustee Rozenberg and unanimously carried, the Board accepted the proposal from Bayport Flower House for (64) flower baskets for Spring of 2023 at a price not to exceed \$3808.
