Dear Neighbors:

I hope you are enjoying the Thanksgiving Holiday. I am pleased to advise that this month's meeting will be held on **Tuesday**, **November 29**, **2022**, **at 7:00 p.m.** at Village Hall. As always, we welcome your attendance and participation.

In addition to our usual business, we have a public hearing scheduled on a proposed local law, related to exterior **construction work performed on Saturdays.** Our code currently prohibits work on Sundays and numerous residents have requested that the Board consider expanding the limitation to include Saturdays in order to preserve the peaceful enjoyment of our community on weekends. In response, the Board voted at our recent meeting to schedule the hearing for the proposed limitation on construction work performed on the exterior of homes on Saturdays.... interior work that does not create noise will still be permitted. Surrounding Villages have previously implemented similar laws which provide limitations on the ability to perform construction work on Saturdays. Comments regarding the proposed law can be submitted in writing to the Village prior to the meeting or made at the meeting.

As a reminder, if you plan to be out of town for the holidays or over the winter season, you might consider making sure your home appears occupied while you're away. As in the past, we suggest notifying Village Hall of the dates of your absence and we will be happy to complete a vacant premise form on your behalf. This form is recorded with the NCPD 4<sup>th</sup> Precinct and our own Village Security force and will assist in patrolling the neighborhood. This information is kept strictly confidential. Furthermore, we request your help in proactively securing our community by locking your car doors, using your alarm, and keeping your property well illuminated.

At our last meeting it was suggested that we periodically provide residents with certain reminders of Village protocols. Below are a few things we would like to remind you as the winter months are approaching:

- If you are planning on any construction or updating your home, please check with the Building Department if a permit is required.
- After a snowstorm, please refrain from having the snow pushed back onto the Village roads.
- If you see a streetlight out, kindly report it to Village Hall during regular business hours at 516-295-1400.
- Please note that the Village has a website that is very useful when seeking information about permits, important numbers, agendas, local laws etc. You can find this at Woodsburghny.com

As always, we encourage residents to make any suggestions you might like our Board to consider in maintaining our Village as a great place to live.
