A default occurs when any payment due under this agreement is more than ten (10) days late. **The late fee is \$15.** Should any monthly payment become more than ten (10) days past due, you will be charged a late fee. An additional service fee will be assessed for any check, draft, credit card, or order returned for insufficient funds or any other reason. **The insufficient funds fee is \$25.** If the Member is paying monthly dues by electronic funds transfer (EFT), Dynasty Performance Training, LLC reserves the right to draft via EFT all amounts owed by the member including any and all late fees and services fees. Subject to appropriate State and Federal laws.

CANCELLATION AND REFUNDS / RIGHT TO CANCEL: You are permitted to cancel this contract until **MIDNIGHT** of the **THIRD (3rd)** operating day after the date on which you sign the contract. If the facilities or services that are described in the contract are not available at the time you sign the contract, you have until **MIDNIGHT** of the **THIRD (3rd)** operating day after the day on which you received notice of their availability, to cancel the contract. If within this time period you decide you want to cancel this contract, you may do so by notifying Dynasty Performance Training, LLC by any writing mailed or delivered to Dynasty Performance Training, LLC at the address shown on the contract, within the previously described period. If you do so cancel within the previously described period, any payments made by you will be refunded in full. Cancellations will only be permitted after the previously described period in the event that the member moves to a new permanent residence in a location that exceeds **30 MILES** from the Dynasty Performance Training, LLC facility, or the member incurs an injury which prevents physical activity, and participation in Dynasty Performance Training’s services is prohibited by a medical practitioner.
