Entries are limited to the number of dogs that can be run during available daylight hours. Entries will close when this limit is reached, if this occurs prior to the specified closing time. Entries received after limit has been reached will be placed on a waiting list according to postmarked date and the entrant will be notified of this.

Entry is open to all AKC pointing breeds six months of age on or before the test date, that are part of an AKC registered litter or that have been individually registered with AKC or are an FSS registered breed. **BITCHES IN SEASON ARE NOT ELIGIBLE TO PARTICIPATE.**

Entries must be on an official AKC Field Trial or Hunt Test entry forms and can be mailed or emailed. Checks for emailed entries must be received by the closing date. Phone and fax entries will not be accepted. No entry shall specify any conditions as to its acceptance.

Incomplete entries do not constitute a valid entry and will be returned. An entry form must be filled out for each dog and for each day entered regardless of whether they are mailed or emailed in. It is not the secretary's responsibility to fill out or complete entries.

Entry fees will not be refunded in the event that the dog is absent, disqualified, or excused from competition by the action of the judges or the test committee.

BITCHES IN SEASON ARE NOT PERMITTED ON THE GROUNDS

Entry fees will be refunded for bitches in season, if the test secretary receives a request in writing before the start of the test.

- Please check in with the test secretary and line marshal upon arriving on the grounds.
- An outer covering of blaze orange must be worn by all persons that enter the course or bird field during senior and master tests. The hunting test grounds will be the whole of Oak Ridge's property. All live fire on the hunting test grounds the entire day of the test must be supervised by the Captain of the Guns.
- Please notify the test secretary if you handled a dog that passed and were not listed as handler on the entry form to accurately credit you to AKC with your qualifications.
- Please dispose of dead birds and dog waste appropriately.

Breakfast & lunch will be available both days for a nominal charge.

Exit at Barkeyville, PA. Go south on PA 8 (Pittsburgh Rd., William Flynn Hwy) 0.7 miles, turn left onto PA 208 (Clintonville Rd.) go 2.5 miles, turn right onto Georgetown Rd. (street becomes Windy Point Rd) go 2.2 miles to 458 Windy Point Rd. and Club entrance.

From I-80 east:

I-80 to exit 35 (308 Clintonville, old exit 4). Go south on 308 towards Murrinsville-3.0 miles. Turn Rt. on Windy Point Road (no sign for Windy Point Rd. but sign on left side for SR I 005, blue trailer on Rt. Corner). Go 1.8 miles to 458 Windy Point Rd. and Club entrance.

From Route 8:

Route 8 to Harrisville, PA (approximately 5 miles south of 1-80). Go right (east) on Hwy 58 (approx 7 miles) to Hwy 308 (W. Sunbury Rd). Turn left (north), go 6 to 7 tenths of a mile to Windy Point Rd. (no sign for Windy Point Rd. but sign on left side for SR I 005, blue trailer on Rt. Comer) turn left. Go 1.8 miles to 458 Windy Point Rd. and Club entrance.
